Terms and conditions:

- The emoluments of the Senior Research Fellow (SRF)(Rs 31000/-PM + 8% HRA) and Lab cum Field attendant (Rs. 12000/- PM Fixed) will be as per Govt. Of India/ICAR rules.
- 2. The SRF and Lab cum Field attendant positions are purely contractual/non-regular and will be offered initially for a period up to **31.03.2021** and are co-terminus with the project.

- 3. Selected candidates will not be entitled to claim for regular appointments/absorption either in this institute or in ICAR. Non-maintenance of the discipline and failure to perform the assigned duties will make the SRF and Lab cum Field attendant liable for termination during the appointment period as per ICAR rules.
