Owing to the prevailing COVID-19 pandemic, the eligible candidates are requested to send their application in the enclosed proforma along with self-attested scanned copy of the original documents to the concerned PI's e-mail address as given below latest by June 20, 2020. Candidates who will not be able to produce the M.Sc. completion/degree certificate on the date of the interview are not eligible to attend the interview.

After screening the applications, the eligible candidates will be informed about the details of online interview (Date and Time) by email. Original documents will be verified at the time of appointment. If any candidate is found to have submitted false claims at later stage, their candidature will be summarily rejected.

Terms and conditions apply:

- 1. The SRF and Field Assistant positions are purely contractual, non-regular, co-terminus with the project, and will be offered initially for a period up to 31.03.2021 or up to the termination of the project whichever is earlier and maybe further extendable based on satisfactory performance for the remaining period of the project.
- Selected candidates will not be entitled to claim for regular appointments/absorption either in this
 institute or in ICAR. Non-maintenance of the discipline and failure to perform the assigned duties will
 make the SRF and Field Assistant liable for termination during the appointment period as per ICAR
 rules.
- 3. Maximum age limit: For the SRF position & Field Assistant, 35 years for male and 40 years for female. Age relaxation for SC/ST/OBC is applicable as per Govt. of India/ICAR Rules.

- **4.** Candidates should e-mail their duly-signed complete bio-data and scanned self-attested copies of the original documents (marksheet from Class X onward; experience certificate; no objection certificate from their current employer etc.) latest by 20.06.2020. Only the candidates having essential qualifications would be entertained for the interview.
- 5. The interview of eligible candidates will be held online on **June 25, 2020 at 10.00 AM** at **the Division of Agronomy, IARI, New Delhi 110012**.
- 6. Candidates whose near/ distant relative(s) is an employee of the ICAR/IARI has to declare it as per the format (undertaking) given below. Candidates having no near/ distant relative(s) working at ICAR/IARI will also furnish the declaration. If communicated or declared on the date of interview, candidate will not be interviewed.
