***Minimum Qualification:***

- A relaxation of 5% marks shall be allowed at the Bachelor's as well as the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)[Non-Creamy layer]/PwD.
- The candidates who have been awarded a Ph.D. Degree in accordance with the UGC (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) regulation 2009 or the UGC (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) regulation 2016, and their subsequent amendments from time to time, will be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment or appointment of adhoc faculty.
- The candidates who have been awarded Ph.D. Degree before 2009 or were registered for Ph.D. Degree before 2009 shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment or appointment of adhoc faculty subject to the following conditions:

- a. The Ph.D. Degree of the candidate has been awarded in regular mode only;
- b. The Ph.D. thesis has been awarded by at least two external examiners;
- c. An open Ph.D. viva voce of the candidate has been conducted;
- d. The candidate has published two research papers from his/her Ph.D. work out of which at least one is in a referred journal;
- e. The candidate has presented at least two papers, based on his/her Ph.D. work in conferences/seminars.

*Note: The fulfilment of these conditions should be certified by the registrar or the Dean(Academic Affairs) of the University concerned.*

The clearing of NET/SLET/SET will not be required for candidates in such disciplines for which NET/SLET/SET has not been conducted.

**Tenure:** The appointment will be made initially for one year and academic performance of the Ad-hoc faculty will be reviewed before reappropriating him/her for another session.

**Age Limit:** The maximum Age limit for male and female candidates is 40 years and 45 years respectively.

**Monthly Emoluments (Fixed):** The emoluments will be paid as per UGC/ICAR guidelines (Rs. 54000/- + HRA)

1. Appointment will be made solely on contractual positions as per ICAR-IARI Institute norms.

Interested candidates who have sent their application to above cited email, may appear for the Interview, alongwith typed application for the position applied for, addressed to the Director, ICAR-IARI, New Delhi and detailed bio-data affixed with recent passport size photograph of the candidate and self-attested photocopies of certificates in support of age, qualifications, experience, testimonials and other credentials.
6. Candidates must also bring all the original experience/testimonials in support of age, qualifications, experiences etc.
