1. The above post is purely temporary and will be filled on contractual basis initially for a period of one year (which is extendable as per the requirement & guidelines of ICAR).

2. Age Limit: Minimum Age will be 21 years and Maximum Age will be 45 years (relaxation for SC/ST/OBC-Non-Creamy Layer PH candidates as per govt. rules) (5 years for SC / ST years for OBC and 10 years for PH candidates).

Note: The engagement is purely time bound, non-regular and subject to requirement of organisation. The services of the incumbent shall stand terminated on expiry of the period given in the sanction letter or even before, if not found satisfactory. The Competent Authority also reserve the rights to terminate the appointment at any time without assigning any reason thereof. The Consolidated emoluments of Young Professional-II (YP-II) will be Rs. 42,000/- per month as per rules. The candidate cannot claim for any increment. No HRA will be paid to Young Professional – II.
