DETAILS & TERMS & CONDITIONS OF JUNIOR RESIDENT (NON - ACADEMICS) ADHOC BASIS (89 DAYS)

Eligibility Criteria:

1. The Candidates should have passed MBBS including completion of Internship or equivalent degree recognizes by NMC.
2. Only those candidates who have appeared in NEET- PG in 2025 but did not get admission to any Medical College in accordance to rules & regulations of Govt. of Bihar will be considered.
3. For all eligible candidates, maximum one term is allowed. If anyone joins and leaves at any time it will be counted as one term irrespective of duration of work done.
4. Work Experience in Armed Forces, Central/State Health Service and Private Nursing Homes will be taken as equivalent to Junior Residency (Non Academic) for Adhoc 89 days.

Reservation:

1. The Reservation for EBC/SC/ST, Female & Reservation for Disability Quota/ Wards of Freedom Fighters etc. As per Govt. of Bihar
2. For BC/EBC candidate: Candidates must attach certificate valid for the post in format prescribed by the Government of Bihar Which mentions that the candidate does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than 01 year from the date of advertisement.
3. For SC,ST& PWD- certificate should be issue by authorities prescribed by Govt. of Bihar.

Pay Scale:

The Pay matrix of Level -10 (Rs- 56,100) per month plus other usual allowances as admissible for Junior Resident in this Institute.

Tenure:

The tenure of Junior Residency is purely on adhoc basis for a period of 89 days or till appointment on regular basis whichever is earlier. Tenure will be extended after 89 days on the basis of satisfactory work & conduct report from the concerned HoD and written request from the doctor

concerned. If you are interested in applying for the one year Junior Residency post at IGIMS, Patna, you may submit the application form. Please note that this Ad-hoc appointment will not affect or interfere with your Junior Residency appointment.

Document to be attached:

1. Application fee should be in the form of Demand Draft of **Rs- 250/-** for EBC/SC/ ST Candidate (Non - Refundable) in favour of **Director, IGIMS, Patna payable at Patna.**
2. Self – attested copies enclosed with application form: Date of Birth Certificate (10th Certificate), All MBBS Mark –Sheet, Degree Certificate, Internship Completion , NEET –PG Score Card, Caste Certificate (EBC/SC/ST), Non-Creamy Layer Certificate (Form X-A), PWD Certificate and BMC/NMC registration Certificate.

Selection Procedure:

1. Junior Resident Non Academic for Adhoc basis 89 days/ appointment will be according to NEET-PG Score, Panel for 06 month only.
2. The Selected candidates shall be allotted department on the basis of availability of vacancy in that department.

Duties & Responsibilities:

Duties and responsibilities of Junior Residents will be fixed by the Institute from time -to -time as per the requirement in the interest of patient care in the hospital. This includes emergency duties.

Assessment:

At the end of first 89 days of the Junior Residency, each Junior Resident will be assessed and in case his/her performance is not found satisfactory, his/her appointment shall be terminated.

Indian citizen who full fill the essential qualification, are required to participate in the walk-interview as mentioned above, along-with their application form in the prescribed Performa with requisite fee and copies of all supportive certificate/document including all original certificate/document, as proof of age, qualification, Reservation, Caste certificate, Non creamy layer certificate etc. (please produce original certificate, before the interview Board).

GENERAL INSTRUCTIONS

1. Application form can be downloaded from our website www.igims.org. The cost of application from 250/- (Rupees Two Hundred & Fifty) for **EBC/SC/ST** candidate (Non- Refundable) payable to **The Director, IGIMS**, at Patna, in the form of Demand Draft.
2. Candidates employed in Government/Semi Government organization or by any other employer, must submit their application along with **“No Objection Certificate”** issue by the employer at the time of Interview. Otherwise they will not be considered for selection in case of not in employment, candidate must submit in writing that **they are neither employed in any organization nor doing any course anywhere.**
3. Benefit of reservation will be given to Bihar State domicile only and the applicant outside the State of Bihar will not be entitled for the benefit of reservation. It is requested to bring domicile certificate where applicable. Handicapped person/ candidate will be given the benefit of reservation as per Bihar Govt. rule. Person working in Govt. Institution shall be given relaxation as per rule.


4. Number of vacancies, in each department may increase or decrease.
5. Minimum One Month advance notice, duly recommended and forward by concerned HOD is essentially required to quit the Junior Residency programme tenure mid way: failing which, you will be required to deposit money to the Institute equivalent to the amount paid to you at the rate of one month's emoluments.
6. In addition to Pay+ NPA, other allowances will be admissible as per rule.
7. The posts are non- practicing & Private Practice of any kind, direct or in- direct including laboratory, is strictly prohibited.If found guilty, appointment of candidate shall be terminated.
8. Stay in campus is compulsory, if accommodation is provided. If not provided, HRA's admissible as per rule.
9. The Director of the Institute reserves the right to reject/accept any or the application without assigning any reason and cancel the advertisement.
10. Canvassing in any form will be a disqualification.
11. No TA/DA is admissible for attending the counselling & joining the post if selected.
12. A declaration that whether they have filled up- Declaration form and appeared before the NMC Team for the current year, for any Medical college or not, should be submitted with the application.
13. Merit selection by the Selection Committee does not give right of appointment to the candidate. The Institute reserves the right of appointment of candidate's recommended by the Selection Committee.
