(A) MODE OF SELECTION:

- The candidates as recommended by the Screening Committee will be invited for a Trade test in the relevant area. Those who qualify in the Trade test will be invited for a competitive OMR/ Computer based objective type multiple choice examination, which will consist of three papers viz. Paper-I, II & III. Paper-I will be qualifying in nature. The final merit list will be prepared on the basis of the marks obtained by the candidates in Paper-II & III.
- Paper-II & III will be evaluated only for those candidates who secure the minimum threshold marks (to be determined by the Selection Committee) in Paper-I.

1. Benefits under Council Service:

- The post carries usual allowances i.e. Dearness Allowance (DA), Transport Allowance (TA), House Rent Allowance (HRA) etc., as admissible to the Central Government employees and as made applicable to council employees at CSIR-IHBT, Palampur as per 7th CPC.
- In addition to the emoluments indicated against each category of posts, benefits such as reimbursement of Medical expenses, Leave Travel Concession, House Building Advance, CEA, etc. are available as applicable to Council employees.
- The posts will be governed by the National Pension System (erstwhile New Pension Scheme) applicable w.e.f. 01.01.2004 as notified by the Government of India and adopted by CSIR vide their letter number 17/68/2001-E.II, dated 23.12.2003 and other instructions issued on the subject.
- CSIR provides excellent opportunities to deserving candidates for career advancement as per CSIR rules.

2. General Conditions and Other Information:

- The applicant must be a citizen of India.
- All applicants must fulfil all the essential requirements of the post(s) and other conditions stipulated in the advertisement as on the last date of receipt of the applications, i.e. **29.12.2025**. They are advised to satisfy themselves before applying that they possess at least the essential qualifications laid down for the post(s) as on the last date of receipt of the offline applications, i.e. **29.12.2025**. No enquiry asking for advice as to eligibility will be entertained
- The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle the candidates to be called for Trade Test & Competitive Written Examination. The duly constituted Screening Committee will adopt its own criteria for short-listing the candidates. The candidates should therefore, mention in the application all the qualifications and experience in the relevant area over and above the minimum prescribed qualification, supported with necessary documents.
- The application should be accompanied by DD/ Banker's Cheque (if applicable) in original duly stapled in front of application form, self-attested latest photograph duly pasted on the application form, two additional recent coloured passport-size photographs must be duly stapled to the top-right corner of the application form for examination purposes, self-attested copies of certificates, marksheets, testimonials in support of age, educational qualifications, experience and community certificates (if applicable), discharge book (if applicable).
- The prescribed qualifications should have been obtained through recognized Universities/ Institutions.
- Incomplete application (without self-attested photograph, without application fee, without proper enclosures (if any), self-attested copies of relevant certificates, etc.) will not be entertained and will be summarily rejected.
- In respect of equivalent clause in Essential Educational Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement, then the candidate is required to produce order/ letter in this regard, indicating the Authority (with number and date) under which it has been so treated otherwise the application is liable to be rejected.
- For documents or certificates issued in languages other than Hindi or English, an attested transcript by a Gazetted Officer or Notary must be provided along with the application form.
- This is for information that, if any declaration given or information furnished by any candidate proved to be false or if he/ she is found to have wilfully suppressed any material information, his/ her candidature may be cancelled

at any stage and/ or he/ she will be liable to removal from service after joining at any stage, and such other action as may be deemed necessary may be taken by the Competent Authority.

- x. Any discrepancy found between the information given in the application and as evident in original documents will make the candidate ineligible for appearing in the trade test/ competitive written examination.
- xi. The date for determining the upper age limit, qualifications and/ or experience shall be the last date prescribed for receipt of offline applications, i.e. **29.12.2025**.
- xii. Canvassing in any form and/ or bringing any political influence or otherwise will be treated as a disqualification for the post.
- xiii. In the event of number of applications being large, CSIR-IHBT may adopt short listing criteria to restrict the number of candidates to be called for trade test and competitive written examination to a reasonable number by any or more of the following methods: -
 - a. On the basis of higher educational qualifications than the minimum prescribed in the advertisement after satisfying essential qualification.
 - b. On the basis of marks obtained in the academic qualification.
 - c. On the basis of experience and/ or Pay Level.
 - d. Any other methodology as deemed fit by CSIR-IHBT.
- xiv. If there will be a tie in the merit list between/ amongst the candidates, then tie will be resolved in the following order of precedence (ascending order), till tie is resolved:
 - a. Candidate with higher marks in the papers of concerned subject/ trade placed higher.
 - b. Candidate with lesser negative marks, if applicable, in the papers of concerned subject/ trade of competitive written examination placed higher,
 - c. Candidate with lesser negative marks, if applicable, in the papers (which have been considered for preparation of merit) of competitive written examination placed higher,
 - d. Date of Birth, with older candidate placed higher,
 - e. Candidate acquiring essential qualification earlier placed higher,
 - f. Alphabetical order in which first names of the candidates appear.
- xv. The decision of the Director, CSIR-IHBT, Palampur, in all matters relating to eligibility, acceptance or rejection of applications, mode of selection, conduct of examination and cancellation of recruitment process/ advertisement at any stage without assigning any reason thereof or reserves the right not to fill up any of the posts, if required will be final and binding on the candidates.
- xvi. Further, all the subsequent information / notification / corrigendum / addendum regarding this recruitment drive will be hosted on the Institute's website only. Hence, applicants are requested to follow the Institute's website i.e. <https://www.ihbt.res.in/en/> for updates.
- xvii. **NO INTERIM ENQUIRY OR CORRESPONDENCE WILL BE ENTERTAINED.**

3. Age & Other Relaxations:

- i. The cut-off date for determining the age limit, qualifications and experience shall be the last date for receipt of offline applications, i.e. **29.12.2025**.
- ii. The upper age limit is relaxable upto 5 years for SC/ ST and 03 years for OBC as per Government orders in force only in those cases where the post is reserved for respective categories. The SC/ ST/ OBC candidates who apply against unreserved (UR) post will not be eligible for age relaxation.
- iii. As per GOI provisions, age relaxation for widows, divorced women and women judicially separated from Husbands who are not remarried, the upper age limit is relaxable upto the age of 35 years (upto 40 years for members of SC/ ST in respect of the posts reserved for them). The persons claiming age relaxation under this sub-para would be required to produce the following documentary evidence:

- a. In case of Widow, Death certificate of her husband along with the Affidavit that she has not remarried since.
 - b. In case of divorced women and women judicially separated from their husbands, a certified copy of the judgement/ decree of the appropriate Court to prove the fact of divorce or the judicial separation, as the case may be, with an affidavit in respect of divorced Women that they have not remarried since.
- iv. Age relaxation for persons with benchmark disabilities (PwBD): Age relaxation of 10 years (15 years for SC/ST and 13 years for OBC candidates, only in those cases where the post is reserved for respective categories) in upper age limit shall be allowed to persons suffering from (a) blindness or low vision (b) deaf and hard of hearing (c) locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy (d) autism, intellectual disability, specific learning disability and mental illness; (e) multiple disabilities from amongst persons under clauses (a) to (d) including deaf-blindness. The age concession to the persons with disabilities shall be admissible irrespective of the fact whether the post is reserved for person with disabilities or not. The persons claiming age relaxation under this sub-para would be required to produce a certificate in prescribed proforma in support of their claims clearly indicating that the degree of physical disability is 40% or more. In any case, the appointment of these candidates will be subject to their being found medically fit in accordance with the standards of medical fitness as prescribed by the Government for each individual such posts.
- v. Age relaxation to Ex-servicemen will be as per GOI orders.
- vi. All statutory categories (SC/ ST/ OBC(NCL)/ EWS/ PwBD/ ESM, etc.) candidates seeking any kind of relaxation are required to submit a copy of the applicable certificate in the prescribed format as the case may be (**Annexure I, II, IV, V, VI, VII & XII**) signed by the specified authority valid for appointment of posts under the Central Government), failing which claim for SC/ ST/ OBC/ EWS/ PwBD/ ESM, etc will not be entertained and the candidature/ application will be considered under Unreserved (UR) category. In addition, the OBC (NCL) candidates have to submit a declaration as per **Annexure III**.
- vii. Upper age limit is also relaxable upto five years for the regular employees working in CSIR Laboratories/ Institutes, Government Departments, Autonomous Bodies, and Public Sector Undertakings.
- viii. Temporary/ contractual employees working in CSIR laboratories/ Institutes, Government Departments, Autonomous Bodies and Public Sector Undertakings should mention **“NO”** in the Government Employee Status.

4. Provisions of Compensatory Time and assistance of scribe for PwBD:

- i. In case of persons with benchmark disabilities in the category of Low Vision and Locomotor Disability and cerebral palsy, the facility of scribe is provided, if desired by the candidate.
- ii. The provision of scribe will be available on production of a certificate to the effect that the person concerned has physical limitation to write, and scribe is essential to write examination on his/ her behalf, from the Chief Medical Officer/ Civil Surgeon/ Medical Superintendent of a Government health care institution as per proforma at **Annexure-VIII or Annexure-XI**.
- iii. The candidate will have the discretion of opting for his/ her own scribe or the facility of scribe provided by the IHBT. Appropriate choice in this regard will have to be given by the candidate through email to Section Officer (Recruitment) at email id **“sorecruitment@ihbt.res.in”**.
- iv. In case the candidate opts for a scribe, the qualification of the scribe should always be matriculation or above but not be more than the minimum qualification criteria of the examination. The scribe should not be a candidate of this examination.
- v. The candidates with benchmark disabilities opting for own scribe shall be required to submit details of the own scribe as per proforma at **Annexure-IX or Annexure-X**. In addition, the scribe has to produce a valid ID proof in original (Aadhaar Card, Voter ID Card, PAN Card etc.) at the time of examination. A photocopy of the ID proof of the scribe signed by the candidate as well as the scribe will be submitted along with proforma at **Annexure-IX or Annexure-X**. If subsequently it is found that the qualification of the scribe is

not as declared by the candidate, then the candidate shall forfeit his/ her right to the post and claims relating thereto.

- vi. A compensatory time of 20 minutes per hour of examination will be provided to the persons who are allowed use of scribe as described at Para 4 (i) & (ii). The candidates referred at Para 4 (i) & (ii) who are eligible for use of scribe but not availing the facility of scribe will also be given compensatory time of 20 minutes per hour of examination.
- vii. No attendant other than the scribe for eligible candidates will be allowed inside the examination hall.
- viii. Partially blind candidates who are able to read the normal Question Paper set with or without magnifying glass and who wish to write/ indicate the answer with the help of magnifying glass will be allowed to use the same in the Examination Hall and will not be entitled to a Scribe. Such candidates will have to bring their own magnifying glass to the Examination Hall.
- ix. The PwBD candidates who have availed the facility of Scribes/ Passage Reader and/ or compensatory time must produce relevant documents for the eligibility of scribe/ compensatory time at the time of Document Verification. Failure to produce such supporting documents will lead to cancellation of their claims thereto or candidature for the examination/ test etc., as the case may be. The decision of the Competent Authority of this Institute will be final and binding.

5. Application Fee:

- i. Candidates belonging to General / OBC / EWS category are required to pay application fee (non-refundable) of **Rs.500/- [Rupees five hundred only]** by way of Demand Draft/ Banker's Cheque drawn in favour of **"The Director, CSIR-IHBT, Palampur (H.P.)"** payable at Palampur (Himachal Pradesh) and fill up the Demand Draft/ Banker's Cheque detail in the prescribed columns of the applications. No other mode of payment will be accepted.
- ii. The candidates belonging to SC/ ST/ Women/ PwBD/ Ex-Servicemen (ESM) are exempted from payment of application fee as per rules.

6. Centre for Trade Test and Written Competitive Examination:

- i. The trade test and written competitive OMR/ Computer based objective type multiple choice examination will be held in Palampur. However, it can be conducted in any city or cities as may be decided by CSIR-IHBT, Palampur and no representation regarding change of centre will be entertained.
- ii. The date, time and venue of the trade test and written competitive OMR/ Computer based objective type multiple choice examination will be intimated well in advance to the candidates through CSIR-IHBT website as well as through email id/ registered post to the address provided by the candidates in their application form.
- iii. Candidate will have to bear the cost of their travel, boarding and lodging for appearing for trade test and written competitive OMR/ Computer based objective type multiple choice examination.

7. How to apply:

- i. Eligible candidates are required to apply offline using the proforma available on the CSIR-IHBT website. No other mode of application will be accepted.
- ii. Candidates belonging to General, OBC and EWS category are required to pay an application fee (non-refundable) of ₹500/- (Rupees Five Hundred Only) by way of Demand Draft/ Banker's Cheque drawn in favour of **"The Director, CSIR-IHBT, Palampur (H. P.)"** payable at Palampur (Himachal Pradesh). SC/ ST/ Women/ PwBD/ Ex-servicemen (ESM) are exempted from submission of application fee as per rules.

- iii.
