2. The age limit for YP-II is up to 45 years and for SRF is 35 years for men and 40 years for women as on the date of the interview with relaxation as per rules.
3. The Candidate should attend the interview with duly filled – in application form (as per the format – Annexure 1 Enclosed) with a photograph affixed on it and signed. **Duly filled in application form is compulsory.**

4. All the relevant original testimonials (date of birth, degree certificate, experience certificate, etc., if any) are to be shown and a set of attested copies of all the certificates will be required to be submitted by the candidates for verification, before joining, if selected. ***If any candidate is found to have submitted false information/claims at any stage, their candidature will be summarily rejected or the appointment will be terminated.***
5. **No TA/DA any other expenses will be paid for attending the interview**
6. Candidates should bring their complete Bio Data, duly self-attested certificates mark sheets (from class 10th onwards), experience certificates and no objection certificates from their current employer at the appointment time. **only the candidates having essential qualifications would be allowed to attend the interview**
7. No objection and experience certificate are required from the employer; in case he/she is employed.
8. Concealing of the facts or canvassing in any form shall lead to disqualification or termination of the candidate. The decision of the competent authority will be final and binding in all respects.
