Important qualification-related criteria:

➤ Graduate Engineering (Grade A):

- Candidates pursuing/completed ME/M.Tech as part of Integrated Course or Dual Degree course of BE/B.Tech program are eligible to apply, provided they have completed BE/B.Tech in one of the disciplines mentioned above. Such candidates must have both BE/B.Tech and ME/M.Tech final marksheet/degrees by 30th September 2026. Percentage of marks/CGPA for such candidates shall be calculated as below to determine their eligibility:
 - a) Dual degree (awarded two separate degrees i.e. BE/B.Tech and ME/M.Tech) - percentage of marks/CGPA in BE/B.Tech only will be considered.
 - b) Integrated degree (single degree is awarded i.e. ME/M.Tech at the end of integrated ME/M.Tech program) - the percentage of marks/CGPA obtained by the candidates in overall ME/M.Tech program will be considered.
- Candidates having their Graduation (BE/B.Tech) in combined/ integrated disciplines/ inter-disciplinary subjects like Mechatronics/ Robotics etc. will not be eligible.

➤ **Marketing (Grade A):**

The specialization in qualifying degree should find mention in the final degree certificate, Onus to establish specialization pursued by candidate in Qualifying degree examination lies with candidate and the same must be substantiated either through Final Degree Certificate or certificate issued by appropriate authority. Majority of the elective papers in the qualifying degree should conform to Marketing specialization.

➤ **Law (Grade A):**

- The LLB degree should be recognized by the Bar Council of India.
- The candidate should produce the Original registration certificate with Bar Council of India at the time of Document verification (applicable for those candidates who are claiming work experience of law firms, chambers of practicing advocates and/or engaged in independent practice in the field of law).

➤ **Quality Control (Grade A0):**

- Any other branch of M. Sc. (Chemistry) e.g. Biochemistry, Pharmacy, Toxicology, Geochemistry, Pharmacology, Food Technology etc. will not be considered towards eligibility.

➤ **Diploma Engineers (Grade E0):**

- A Sandwich Diploma course (with Industrial training as part of the course with no break) shall be considered eligible.
- Diploma under recognized lateral entry scheme (Class–XII (Science)/ITI admitted in 2nd year of Diploma course) shall also be considered eligible subject to meeting prescribed percentage of marks on the basis of aggregate of 4 semesters in the diploma course.
- Candidates having their diploma in combined / integrated disciplines/ inter-disciplinary subjects will not be eligible.
- **Safety (Grade E0):** The onus to establish the recognition of the Diploma in Industrial Safety certificate and period of diploma lies with the candidate and the same must be substantiated through certificate issued by appropriate authority.

➤ **Higher Qualifications (Applicable for Diploma Engineer in Grade E0)**

- Candidates possessing professional qualifications such as Bachelor of Engineering (BE), Bachelor of Technology (B.Tech), Masters in Business Administration (MBA), Chartered Accountant (CA), Company Secretary (CS), Cost Management Accountant (CMA), Masters of Computer Applications (MCA), Doctor of Philosophy (Ph.D) etc. shall NOT be eligible.
- However, Qualifications other than Professional qualifications will not be a disqualification. In such cases, percentage acquired in prescribed qualifications of Diploma Engineering in the respective discipline will only be reckoned for deciding eligibility.
- The aforesaid list of higher qualifications/higher professional qualifications mentioned above is only indicative and not exhaustive. Management may determine any other qualification as a higher qualification/higher professional qualification which is/ are not listed above. The decision of the Management in this regard shall be final and binding and no further enquiry shall be entertained in this respect.
- Suppression of information regarding possession of or pursuing higher qualification/higher professional qualification shall render a candidate ineligible for consideration at any stage of selection and termination at any time during employment, if recruited.

Common Points for all posts:

- Applicants should be in a position to produce final degree/marksheet by 30th September 2026 and obtain minimum percentage of marks as mentioned from aggregate of marks obtained in semesters declared so far. If shortlisted/selected, they would be allowed to join only if, besides meeting other eligibility criteria, their aggregate percentage of marks in the qualifying examination is equal/more than the minimum percentage of marks as prescribed.
- Any qualification as mentioned in aforesaid tables, acquired through Part-time/ Correspondence/ Distance/ Online Learning mode will not be eligible.
- Candidates having qualifying degree/diploma from a discipline other than those mentioned, are not eligible to apply. However, the Corporation reserves the right to take a final decision in considering any discipline eligible in case the same is different from those mentioned.
- Percentage of marks in Qualifying Degree/Diploma shall be calculated as per respective Institute/University norms.
- Degree/Diploma awarded by the Institutes/Universities (including foreign institutes/ universities) must have equivalence from the Association of Indian Universities (AIU)/ UGC and candidates, in their own interest, as applicable, should ascertain the equivalence of their diploma/degree/certificate with degree of recognized Indian universities by the Association of Indian Universities (AIU)/ UGC.
- Wherever final marks in the qualifying degree have been awarded as letter/number grade (CGPA/GPI/SGPA/DGPA/OGPA/CPI etc.), equivalent percentage of marks for establishing eligibility criteria shall be arrived at by referring to applicable percentage conversion formula adopted by respective Institute/University. Such candidates must submit the conversion certificate issued by the concerned Institute/University during Document Verification at the time of GD, GT & Personal Interview, if shortlisted. The fraction of percentage so arrived will not be rounded off to next higher whole number i.e. 59.99% and the same will be treated as less than 60%.

However, in case the Institute does not follow any conversion formula for converting CGPA to Percentage, Candidates from such Colleges/Institutes will have to submit a certificate mentioning that their College/Institute does not follow CGPA to Percentage conversion formula during Document Verification at the time of GD, GT & Personal Interview, if shortlisted. In such cases, IOCL shall be at liberty to arrive at equivalent percentage of marks by adopting a multiplication factor.

3.0 Work Experience:

The post qualification work experience (**as on 30.06.2026**) is required **only** for following posts:

Law Officer:

- Minimum Post-qualification Experience Required:

Candidates must possess minimum cumulative post qualification professional experience as below:

 - Candidates working with Law Firms
 - Candidates working with Private/ Public Sector Organizations handling Legal functions
 - Candidates working with Central/ State Governments handling Legal function

➤ **Essential Work Experience Areas:**

Candidates should have experience of working in any of the following areas:

a) Handling litigation (Civil, Consumer and Criminal matters) before different Judicial/ Quasi-Judicial Forums,

b) Arbitration conciliation and other dispute resolution mechanisms,

c) Drafting & vetting various legal or contractual documents, providing legal opinions, handling legal matters including issues pertaining to Mergers, Acquisitions & Joint Ventures, Regulatory matters, etc.

- Decision to accept any or all work experience claimed by the candidate in line with the above paras lies solely with IOCL.
- **Proof of Experience:** Candidate [if shortlisted] shall furnish work experience document(s) in Original issued by the respective organization(s) / Law Firm(s) / Court(s) / Government Office(s) on respective letter head at the time of document verification containing following:
 - a) Name of organization / Law Firm / Courts / Government Offices
 - b) Work Profile along with designation in the organization / Law Firm / Courts / Government Offices
 - c) Date of Service Period (From – To) for Organization/ Law Firm/Govt. Offices.For lawyers working independently in courts shall furnish record of appearances issued by respective courts. The period between the oldest appearance and the latest appearance (before **30.06.2026**) shall be referred for establishing work experience criteria.

In the absence of any of the aforesaid details on letter head, IOCL shall be at liberty to summarily reject the candidature of the candidate at any stage of the recruitment process.

- Internships, Teaching experience, Part Time Work or any other work experience gathered as a part of acquiring qualification, or short-term trainee (summer/ winter project etc.) will not be considered as relevant experience.
- **Desired Skill:**
 - a) Knowledge of all applicable laws, rules and regulations
 - b) Excellent written and verbal communication
 - c) Having experience in Oil & Gas/Petrochemical Industry
 - d) Ability to prepare complex legal documents.

Assistant Quality Control Officer:

- Minimum 02 Years of Cumulative post qualification Experience in following:

- Experience gained after the date of declaration of result of qualifying degree will only be considered towards counting experience. Any experience gathered after B. Sc. or as short- term trainee (summer/winter project etc. during M.Sc.) will not be considered towards relevant experience.
- Teaching & Research experience in an academic institute will not be considered as relevant experience.
- Decision to accept any or all work experience claimed by the candidate in line with the above paras lies solely with IOCL.
- **Proof of Experience:** Candidate shall have to furnish relevant and valid documents in original issued by the respective organization(s) on its letter head containing following in support of work experience:

5.0 Reservation

- Reservation of vacancies for candidates from OBC(NCL)/SC/ST/EWS/PwBD categories will be available as per directives of Government of India (GOI).
- Candidates belonging to OBC(NCL)/SC/ST/EWS/PwBD categories should have valid certificate in support of their claim of belonging to such category, to be eligible for claiming reservation under the respective category.
- Prescribed reservation for PwBD will be applied on horizontal basis as per Govt. Guidelines.
- In case it is found at any stage of recruitment process or any time after recruitment, that the candidate has obtained reservation benefits by submitting false/ incorrect certificate/ information; the candidature of such candidates will be cancelled, and services terminated immediately.
- **For getting the benefits of reservation under Scheduled Caste (SC) / Scheduled Tribe (ST) category:**
 - Name of Caste / Tribe to which candidate belongs must appear in the Central List of SC and ST of respective State as notified respectively by Ministry of Social Justice and Empowerment, Govt. of India (<https://socialjustice.gov.in/>) and Ministry of Tribal Affairs, Govt. of India. (<https://tribal.nic.in>).
 - The Caste / Tribe certificate must contain date of issue along with certificate number and the name of the Caste / Tribe. The name of the Caste/Tribe mentioned in the certificate should be spelled exactly in the same manner as appearing in the central list of SC/ST for the respective State.
 - Candidates should be able to produce SC/ST certificate issued by the Competent Authority in the latest prescribed format applicable for purpose of reservation in appointment to posts under Government of India/Central Government Public Sector Undertaking.
 - SC/ST candidates belonging to the State of Maharashtra must have valid Caste Validity certificate issued in his/her name issued by Government of Maharashtra.

➤ **For getting the benefits of reservation under Other Backward Classes (Non-Creamy Layer) OBC(NCL) category:**

- The certificate must contain date of issue along with certificate number and the name of the caste. The name of the caste mentioned in the certificate should be spelled exactly in the same manner as appearing in the central list of OBCs for the respective State.
- The OBC category candidates who belong to “CREAMY LAYER” are not entitled for OBC(NCL) concession/reservation and such candidates shall have to apply as “General” category candidate.
- The OBC(NCL) certificate should be issued on or after 01.04.2026 by the Competent Authority.

Candidate needs to affix recent recognizable photograph on the call letter preferably the same as provided during registration and appear at the examination centre with (i) Call Letter (ii) Photo Identity Proof as stipulated in clause 8.6 below and also specified in the call letter and photocopy of the same Photo Identity Proof as brought in original.
8.5 Candidates Reporting Late	a. CANDIDATES REPORTING LATE i.e. after the reporting time specified on the call letter for Examination will not be permitted to take the examination.
