**Horizontal Reservation for Persons with Benchmark Disabilities (PwBD)**

As per the instructions of the Government of India, 4% horizontal reservation i.e., **four (4) posts** are allotted for PwBD in the total vacancy. The following posts across four Departments namely Anatomy, ENT, Pharmacology and Microbiology **have been identified suitable for candidates applying under PwBD and are RESERVED for PwBD:**

- a) **Professor of Anatomy (1 EWS)**
- b) **Additional Professor of ENT (1 OBC)**
- c) **Associate Professor of Pharmacology (1 UR) and**
- d) **Assistant Professor of Microbiology (1 OBC)**

The candidates belonging to identified PwBD category may apply for any of the above mentioned posts, subject to fulfillment of other eligibility conditions as prescribed for the concerned post. The candidates selected under PwBD category will be adjusted against the vacancy of respective categories of OBC/UR/EWS as the case may be.

The persons who suffer from not less than 40% of disability will only be eligible for the benefit of reservation and other relaxations under PwBD category as permissible under the rules. The applicant must have a valid Disability Certificate issued from the competent authority i.e. Medical Board duly constituted by the Central or the State Government. Certificates issued by the Medical Practitioner, Hospital or any other Institution will not be considered. **The physical disability of the selected candidate will be ascertained by a Medical Board of the Institute/Mentor Institute specifically constituted for this purpose.**

- (i) **Unreserved (UR):** Unreserved stands for all applicants including OBC/SC/ST/EWSs. (Only such SC/ST/OBC/EWSs candidates who are selected on the same standard as applied to general candidates shall be treated as own merit candidates. If any SC/ST/OBC/EWS candidate is selected by getting any relaxation in age, etc., he/she shall be counted against reserved vacancies. Such a candidate cannot be considered for appointment against an unreserved vacancy)

- (iv) **Persons with Benchmark Disability (PwBD):** The minimum degree of disability should be 40% (Benchmark Disability) in order to be eligible for availing reservation for persons with specified disability. The Percentage of the candidates' disability will be assessed by medical board and the decision of the medical board will be final in this regard.

- (v) **Economically Weaker Sections (EWSs):** Candidates who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below Rs.8.00 lakh (Rupees Eight Lakh Only) are to be identified as EWSs for benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application.

Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:

- 5 acres of agricultural land and above;
- Residential flat of 1000 sq. ft. and above;
- Residential plot of 100 sq. yards and above in notified municipalities;
- Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status. The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years. (As per the Office Memorandum F.No.36039/1/2019 dt 31st January 2019 by Ministry of Personnel, Public Grievances& Pension & F.No.A11013/01/2019 dt. 28th February 2019 by Ministry of Health & Family Welfare, Government of

19. Decision of the competent authority of AIIMS, Madurai in all matters regarding eligibility/selection would be final and binding on all applicants/candidates. No correspondence whatsoever would be entertained by the AIIMS, Madurai in this regard.
20. **Mode of selection: Personal interview / Online by video conferencing** (In case, if huge number of applications are received for any of the discipline then a written exam will be conducted for shortlisting the candidates (OR) the Standing Selection Committee may shortlist candidates for the interview). **The decision of the competent authority of AIIMS, Madurai is final.**
21. **Interviews** to the advertised posts will be held in a **phased manner**. The decision of the competent authority of AIIMS, Madurai in this regard is final and no correspondence in this regard will be entertained.
22. No TA/DA will be paid for attending the Personal interview.
23. The **initial place of posting** of the appointee will be at a temporary location for AIIMS, Madurai i.e., at **Government Medical College, Ramanathapuram, Tamil Nadu** and shall be transferred based on the progress of the project of AIIMS, Madurai. The decision of the competent authority of AIIMS, Madurai in this regard is final.
