The application format Form 'A' for the post of Superintending Engineer(Civil) along with, essential qualifications, benefit of reservation, application processing fee and terms / conditions , selection criteria etc. are available and can be downloaded from the University website www.luvass.edu.in . The duly filled in application form complete in all respect along with self-attested photo copies of required certificates, documents and Demand Draft should reach "The Registrar, LUVAS, Hisar-125004" **on or before 30.06.2020 (07.07.2020 for candidates residing abroad). Application processing fee (details given in Table 1) in the shape of Demand Draft of any Nationalized Bank drawn **in favour of "The Registrar, LUVAS, Hisar"** and **payable at Hisar** should be attached with each application form. In-service candidates should apply through proper channel or produce "No Objection Certificate" from the appointing authority otherwise they will not be allowed to appear in interview/verification of documents. However, they must submit an advance copy along with application processing fee and self-attested copies of all the documents on or before the last date of receipt of application form.**

Important Note: The advertisement for the post of Superintending Engineer (Civil) advertised vide Advt. No. 1/2020 is hereby withdrawn. The candidates who had applied earlier for this post in response to Advt. No. 1/2020 need not to apply again. Their earlier application will be considered, however, they can update their application form by submitting supporting documents to reach this office on or before the last date for receipt of application form i.e. 30.06.2020 (07.07.2020 for candidates residing abroad).

- (iii) Age Limit: Upto 55 years.

INSTRUCTIONS / CONDITIONS

Special Instructions

- 1- The applicant must possess prescribed qualifications on the last date of receipt of applications. If a candidate is found ineligible at a later stage, his candidature will be rejected. The fulfilment of prescribed essential qualifications will not entitle a candidate to be called for interview/ final selection. The decision of the University in all matters relating to acceptance or rejection of an application, eligibility/suitability of the candidates, mode of and criteria for selection etc. will be final and binding on the candidates. No inquiry or correspondence will be entertained in this regard.

General instructions

- 2- The candidate should give details of all the examinations passed from Matriculation or its equivalents to onwards and mention total and percentage of marks obtained and maximum marks in each examination. The candidate, who has obtained degree or Diploma or Certificates for the various courses from any institution declared fake by the University Grants Commission/VCI and other institutions/agencies, shall not be eligible for being considered for recruitment to the post(s) advertised.
- 3- No concession of fee is admissible to SC/BCA/BCB//EWS/Persons with disabilities/ESM and women candidates of other States.
- 4- Candidates already in regular/temporary/ad hoc/contract service must apply through proper channel or produce "No Objection Certificate" from the appointing authority otherwise they will not be allowed to appear in interview/verification of documents. They may, however, submit an advance copy alongwith prescribed application processing fee & self-attested copies of all the documents.
- 5- Applications which are incomplete/not on prescribed application form of LUVAS/ received late will not be considered. The University shall not be responsible for any postal delay/lapse.
- 6- The number of post indicated in the Advertisement can vary. The University also reserves the right to withdraw / add one or more of the post(s) advertised.
- 7- Besides pay, as per scale mentioned in the advertisement, ADA, HRA, Medical Allowance etc. are admissible as per University rules adopted from time to time.
- 8- Minimum age limit is 18 years. The maximum age limit for the post of superintending Engineer (Civil) is 55 years.
The retirement age for University Employees is 60 years.
- 9- No TA/DA shall be paid by the LUVAS for any written examination/verification of documents/interview.
- 10- **Reservation of posts - This post belongs to General Category.** However, if any, benefit of reservation will be admissible only to those SC/BCA/BCB/EWS/ Persons with disabilities/ESM/DESM/Eligible Sports Persons/DFF candidates who are domicile of Haryana State. Reservation will be as per Haryana Govt. instructions adopted by the University.
The dependent sons/daughters of ESM who fulfil all conditions of qualifications, age etc. prescribed for posts will be considered on merit for the posts reserved for ESM, if any, if suitable ESM candidates are not available. The children and the grand-children of Freedom Fighters (DFF) would be considered to the extent mentioned in Haryana Govt. letter No.22/20/83-3GSIII dated 26-7-1984 as amended from time to time, if the quota reserved for Ex-servicemen, remains unfilled due to non-availability of suitable Ex-servicemen or their dependents.



ESM/DESM candidates of Haryana claiming benefit will have to produce the fresh Eligibility Certificate from the concerned Zila Sainik Board at the time of interview. Mere dependent certificate will not be entertained. ESM candidates should also produce at the time of interview attested photo copy of identity card issued by concerned Zila Sainik Board.

NONE OF THE PERSON MENTIONED BELOW SHALL FALL WITHIN DEFINITION OF WARD/ DEPENDENT OF EX-SERVICEMEN IN TERMS OF HARYANA GOVT. LETTER NO.12/37/79-GSIII DATED 21-11-1980:-

- i) A person may be working on an ad hoc basis against the post advertised or somewhere else.
- ii) A person may be unemployed at the time of making the application but he may have other source of income viz., from agriculture, trade, property, bank balance etc.
- iii) A person who is a member of the joint Hindu family and remains dependent upon the Karta till there is partition in the family or he/she ceases to be a member of the joint Hindu family and is obliged to pass on all his/her income to the Karta and he/she draws money for his/her subsistence from the pool of the joint Hindu family with the consent of the Karta.
- iv) A candidate who is a member of the joint Hindu family is employed on ad hoc basis but he/she is otherwise dependent on his/her father.

Note: i) **The benefit of reservation will be given only to those SC/BCA/BCB/EWS/ Persons with disabilities/ESM/DESM/Eligible Sports Person and DFF candidates who are domicile of Haryana State. The SC/BCA/BCB/EWS/Persons with disabilities/DFF candidates are required to submit SC/BCA/BCB/EWS/Persons with disabilities/DFF certificate duly issued by the competent authority at the time of interview/document verification. Likewise the Eligible Sportsperson shall be required to submit the sports gradation certificate at the time of interview/document verification as per Government instructions duly issued by the competent authority. DESM shall be required to produce the fresh Eligibility Certificate duly issued by the respective Zila Sainik Board at the time of interview.**

- 11- Qualifications, age and other aspects such as experience, publications, academic awards and documents etc. to be considered for structural marking will be determined with regard to the last date fixed for receipt of applications.
- 12- Candidates applying for a post must ensure that they fulfil all the eligibility conditions on the last date fixed for receipt of application. If on verification, at any time before or after the written examination or interview/document verification or appointment, it is found that they do not fulfil any of the eligibility condition or it is found that the information furnished is false or incorrect, their candidature will be cancelled.
- 13- The original certificates are required to be produced by those candidates who qualify / called for the interview.
- 14- **An application form will be summarily rejected in the following events:-**
 - i) If a candidate makes more than one application form for the same post.
 - ii) If the application is not on the prescribed application form.
 - iii) If the application is unsigned/incomplete.
 - iv) If the experience certificate is without detail of salary per month received (wherever the condition of experience apply).
 - v) If in-service candidates who apply through proper channel do not attach duly certified check list along with their application form.
 - vi) If a candidate does not possess the qualifications of Hindi/Sanskrit upto Matric standard/Higher Standard.



- vii) If a candidate does not possess the prescribed academic qualifications on the cutoff date.
 - viii) If a candidate is under age/over age on the cut-off date.
 - ix) If the application is received after the closing date, University will not be responsible for any postal delay.
 - x) If the application is without application processing fee.
- 15- Persons appointed at outstations will not be transferred to Headquarter at Hisar for at least 5 years.
- 16- All claims mentioned in the application forms should be supported by relevant and authenticated documents only and such documents/records will be taken into consideration for award of marks.
- 17- Candidates are warned that they should not furnish any particulars that are false, tampered/fabricated or should not suppress any material information while filling up the application form. At the time of written examination/scrutiny, if a candidate is (or has been) found guilty of:
- a) Using unfair means during the examination/interview.
 - b) Impersonating or procuring impersonation by any person.
 - c) Misbehaving in the examination hall/interview room.
 - d) Resorting to any irregular or improper means in connection with his/her candidature for selection.
 - e) Obtaining support for his/her candidature by any unfair means. Not complying with instructions issued from time to time, such a candidate may, in addition to rendering himself/ herself liable to criminal prosecution, be liable
 - i. To be disqualified from the examination/scrutiny for which he/she is a candidate.
 - ii. To be debarred either permanently or for a specified period, from any examination or recruitment conducted by LUVAS.
 - iii. To be terminated from service, if he/she already in this University Service.
- 18- **Mere possession of prescribed qualifications will not entitle a candidate to be called for interview/final selection.**
- 19- All the enclosures must be self-attested by the candidate with date.
- 20- **Photograph affixed on the application form should not be more than three months old. The date on which photo has been taken should be mentioned on the bottom of the photograph. The same photograph as affixed on the application form must be affixed on the admit card at the time of written examination of the candidate (wherever applicable). The candidates whose photograph is found different to that pasted on the application form will not be allowed to appear in the written examination.**
