It can have a dotted relation with CIO/CTO for driving such projects. • CISO should coordinate the activities pertaining to Cyber Security Incident Response Teams (CSIRT) within the bank. • CISO shall develop cyber/IT security KRIs and KPIs and get an independent assessment of the same including its coverage at least on a quarterly basis • CISO shall have a robust working relationship with CRO to enable holistic risk management approach. To this effect, CRO may be invited to information security committee meetings. CISO may be a member of committees on operational risk where IT/IS risk also discussed • CISO'S Prime responsibility is for driving and ensuring compliance of Circulars issued by RBI/CSITE/IFTAS/CERTIN on cyber /IT security framework as issued from time to time and other related extant instructions. • CISO shall responsible for monitoring of the entire IT setup of the bank from IT Security perspective Review the policies/contents of IT Security policies of the Bank. • Any other related duty assigned from time to time.

- The recent photograph is to be pasted at the appropriate place and application should be signed by the candidate. Incomplete and illegible applications will be rejected.
- The cover containing the application should be super scribed with the name of the post applied for i.e. ‘**APPLICATION FOR THE POST OF CHIEF INFORMATION SECURITY OFFICER (CISO) in Grade/Scale-IV.**
- The following documents should be submitted along with the application.
 - Proof of age (copy of passing Secondary/High School/10th standard Certificate or Higher Secondary School /12th Standard Certificate mentioning the DOB).
 - Copy of Certificates and Mark sheets in respect of qualifications (essential and desirable) acquired.
 - Appropriate document(s) in support of experience.
 - Medical Fitness certificate.

2. General rules:

- Application format is appended below. Candidate should apply strictly in conformity with the format as prescribed.
- **Candidates should enclose copies of the relevant certificate/s (in support of age, educational qualification) and appropriate documents in support of the experience, with the application.** Their candidature will be considered on the strength of the information declared in the application and the copies of certificates/ documents submitted therewith. If at any stage it is found that any information furnished in the application is false/incorrect or if according to the Bank, the candidate does not satisfy the eligibility criteria, his/her candidature/appointment is liable to be cancelled/terminated at Bank’s sole discretion.
