Candidates must carry hard copy of all original degree/diploma certificates, Govt. issued ID (Aadhaar/PAN/Voter ID Card etc.), category certificate, recent passport size photograph and one set of photocopies of all original documents duly self-attested at the time of registration, failing which their candidature will not be accepted.
3. The appointment is purely on contractual basis till 31st March 2026 only and does not bestow any right for regular appointment.
4. The total number of posts is tentative and NCERT reserves its right to increase or decrease the number of posts or not to fill up any of the posts advertised without assigning any reason whatsoever.
5. No TA/DA is admissible either for attending the walk-in registration/skill test/interview or at the time of joining the post.

6. The Council reserves the right to relax any of the requirements, i.e., educational qualification, experience etc. in exceptional cases.
7. Cut-off date for determining Age/Experience shall be the date of registration and screening of documents.
