C. <u>REMUNERATION</u>

Consolidated amount of Rs.35000/- (Rupees Thirty Five Thousand only) per month for each Category. The payment shall be made on pro-rata basis depending upon the number of days of attendance. No other allowance will be payable.

D. HOW TO APPLY

 Interested candidates need to submit their application in the enclosed application proforma, which should be duly filled-in and the original application proforma alongwith self-attested copies of certificates regarding date of birth, educational qualifications, post qualification work-experience Certificate(s) and Relieving Order from last employer (if applicable) should reach on or before 14.09.2020 in a sealed envelope superscribed "Application for the engagement as Research Assistant for ICFFTR" at the following address:

- 2. The last date of receipt of complete applications is 14.09.2020, unless extended and notified.
- 3. Incomplete/Unsigned application proforma OR application not in prescribed proforma OR application not supported by self-attested copies of relevant documents OR not fulfilling the eligibility criteria OR application received at any other address other than that as mentioned in the foregoing OR application received after due date shall be summarily 'Rejected' and no queries shall be entertained in this regard.
- 4. No claim of possession of equivalent educational qualification(s) other than advertised educational qualification for a post would be entertained and decision of ICFFTR in this regard would be final and binding.
- 5. Scrutiny and shortlisting of applications would be done on the basis of documents enclosed with the prescribed application form. No interim correspondence by the candidates regarding availability/non-availability of documents would be entertained. Accordingly, candidates are advised to enclose all relevant documents alongwith the hardcopy of application form. All communications would be made to the candidates on the e-mail id submitted by them in their application proforma.

E. TERMS OF ENGAGEMENT

Selected candidate would be required to attend office on daily basis and report to Director General (ICFFTR) or any other designated official. However, services of "Research Assistant" can be terminated at any point of time without assigning any reason thereof. The term may be **curtailed** as per administrative requirements of the ICFFTR at its sole discretion.

F. SELECTION PROCEDURE

Candidates meeting the eligibility criteria will be provisionally shortlisted and called for personal interview. Selection shall be made according to merit drawn on the basis of performance of shortlisted candidates in the interview process. Candidates are required to qualify in the Personal Interview with minimum average of 50% marks in interview. No Travelling Allowance would be payable for attending the interview or joining/reporting for duty upon selection. However, in case of receipt of large number of applications, ICFFTR reserves a right to conduct an online test in Delhi - NCR region and/or any other city(ies) of India for the purpose of short-listing candidates for interview. Neither TA will be paid nor Boarding & Lodging facilities would be arranged/reimbursed for appearing in the online test.

G. GENERAL INSTRUCTIONS

- 1. Canvassing in any form shall disqualify the candidate for engagement as "Research Assistant".
- 2. Only short-listed candidates who are found eligible based on the application submitted will be called for participating in the Selection Process. In case the applicant does not receive any communication within 90 days from the date of publication of this advertisement, it may be presumed that he/she has not been short listed for the Selection Process.
- 3. Requirement of Research Assistants purely on temporary basis is exclusively for ICFFTR and candidates engaged against this advertisement shall not have any claim, including regular or permanent employment in ICFFTR.
- 4. Court of jurisdiction for any dispute pertaining to any issue arising out of this recruitment process will be at New Delhi only to the exclusion of all other Courts.
- 5. In case it is detected that a candidate does not fulfil any of the advertised eligibility criteria or has given false declaration or suppressed any material fact or information having any
