- 2. The terms and conditions for the above engagement shall be as follows:
 - i. The person engaged shall perform his/her duties as assigned by the controlling officer from time to time.
 - The working hours of the NGT are from 9:30 AM to 5:00 PM with lunch break of 30 minutes from 1:30 PM to 2:00 PM with Saturday working (except 2nd Saturday).
