- (iii) Click on the tab About Us>>Vacancies>>Current -Click on the advertisement of Joint Advisor (Plantation) - Online Application.
- (iv) Fill-up the form and furnish the requisite information.

- (v) Following documents are required to be uploaded:-
- Photograph- Scanned copy of coloured passport size photograph in only 'jpg'/'jpeg' or 'png' or 'gif' image types not exceeding 1 MB.
 - Scanned copies certificates in support of essential educational qualification, experience and copy of retirement order from Govt. service and PPO order, only in 'jpg / 'jpeg' or 'png' or 'pdg' types.
- (vi) Click 'Next' button.
- (vii) Application **Preview** may be seen.
- (viii) Option of 'Edit' and final Submit button, are also available.
- (ix) If the Applicant is satisfied with the information furnished, click "Submit" button for submitting the application form through Online. The application form Online may be submitted by **22.06.2020(6:00 PM)**.
- (x) After submission of Application Form, a "Unique Reference Number" along with details entered by the Applicant with subject "Application Acknowledgement" will be generated automatically.
- (xi) Automatically generated "Application Acknowledgement" would be sent to the E-mail ID provided by the Applicant.
