

Selection Process

Shortlisting of applications: A Committee duly constituted by the Director, CSIR-NML, will shortlist the candidates fulfilling the qualifications (s), terms and conditions of this advertisement. The Committee will adopt its own criteria for short listing the candidates to call them for further stage of recruitment process.

Skill Test: The candidates as shortlisted by the Committee will be called for Skill Test which is qualifying in nature.

Competitive Written Test: Those who qualify the Skill Test will be called for Competitive Written Examination.

Evaluation of Papers and Final merit list: The final merit list will be prepared on the basis of the performance of the candidates in the Competitive Written Examination. The threshold for shortlisting / selection during each stage of selection process will be decided by the Competent Authority, CSIR-NML which will be binding on all the candidates.

Following Methodology for resolution of tie cases wherever two or more candidates have secured equal aggregated marks for the posts of Driver will be treated in order or precedence till tie is resolve:

- i. Candidate with lesser negative marks, in the Competitive Written Examination, will be placed higher;
- ii. Date of Birth, with older candidate placed higher;
- iii. Candidate acquiring minimum education qualification earlier, placed higher;
- iv. Alphabetical order in which first names of the candidates appear.

The Centre, date and time for Skill Test as well as for Competitive Examination shall be intimated to all the applicants through CSIR-NML web site and e-mail to the e-mail IDs mentioned by the candidates in their respective application forms, well in time.

General Information and Conditions

1. Benefits under Council Service:

- A. All New Entrants will be governed by the "New Pension Scheme" based on defined Contributions for new entrants recruited in Central Government Services on or after 01.01.2004, as adopted by CSIR for its employees. The entitlement of pension, if any, at CSIR / CSIR-NML under a particular pension scheme of Government of India, in case of persons selected from other Government Departments/Autonomous Bodies/Public Sector Undertakings/Central Universities, will be regulated as per the provisions of CCS (Pension), Rules, 1972 (now-2021).
- B. The post carries usual allowance i.e., Dearness Allowance (DA), House Rent Allowance (HRA), Transport Allowance (TA) etc. as admissible to the Central Government employees and as made applicable to CSIR. Council employees are also eligible for accommodation of

their entitled type as per CSIR Residence Allotment Rules-2022 depending on availability in that case HRA will not be admissible. The selected candidate will have to stay in CSIR-NML staff quarters, in case the Competent Authority, CSIR-NML desires for so.

- C. In addition to the emoluments indicated above, benefits such as reimbursement of Medical Expenses, Leave Travel Concession, Computer Advance and House Building Advance are available as per CSIR rules.
- D. The normal place of posting is CSIR-NML, Jamshedpur including its centre located in Chennai. However, the appointee can be posted to work in any Section/Division in any of Laboratories / Institutes of CSIR including their field centres/regional centres in any part of India on the discretion of the Competent Authority, CSIR-NML.
- E. CSIR provides career advancement as per rules applicable to this post under Isolated category.
- F. The appointment to the post shall be governed by the provisions of the Central Civil Services (Conduct) Rules, 1964, Central Civil Services (Classification, Control and Appeal) Rules, 1965, as amended from time to time and other service rules, to the extent made applicable to the Council Servant and decision of CSIR on their applicability shall be final and binding.

2. Other Conditions:

- A. The applicant must be a citizen of India.
- B. All applicants must possess the essential qualification of the post and fulfil other conditions stipulated in the advertisement. They are advised to satisfy themselves before applying that they possess at least the minimum essential qualifications laid down for the post which is compulsory even if a candidate has some other higher qualifications. **Enquiries asking for advice regarding eligibility will not be entertained**.
- C. The experience of driving of motor car for at least three years must have been acquired after obtaining the valid Driving Licence.
- D. The candidate should, mention in the application all the qualifications and experience, if any, in the relevant area supported by documents and ensure that all details are in full and accurate.
- E. The Competent Authority, CSIR-NML has the right to amend, delete or add terms & conditions to this advertisement.
- F. In respect of the equivalent clause, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement, then the candidate is required to produce order/letter in this regard, indicating the Authority (with number and date) under which it has been so treated otherwise the application is liable to be rejected. The decision of the CSIR-NML/ CSIR with regard to equivalence of qualification(s) and about recognition of Universities / Institutes / Boards / Councils shall be final and binding.
- G. If any document/certificate furnished is in a language other than Hindi or English, a transcript of the same either in Hindi or English, duly attested by a Gazetted Officer or Notary is to be submitted also with Application Form.

- H. Date of Birth filled by the candidate in the Application Form must match with the date recorded in Matriculation / Secondary School Certificate. Subsequent request for change in date of birth will not be entertained.
- I. Candidate shall not be reimbursed / paid any Travelling Allowance / Daily Allowance for appearing in Skill Test and / or Competitive Written Examination.
- J. The decision of CSIR-NML/CSIR in all matters relating to eligibility, acceptance or rejection of applications, mode of selection and conduct of examination, venue, date and time of test(s) will be final and binding on the candidates. No enquiry or correspondence will be entertained in this connection from any individual or agency on behalf of the candidate.
- K. Canvassing in any form and/or bringing any influence, political or otherwise will be treated as a disqualification for the post.
- L. The selected candidate will be on **probation for two years** from the date of taking over the charge of the post. The probationary period may be extended or curtailed at the discretion of the Competent Authority, CSIR-NML.
- M. Applicants must disclose as to whether any of their close or blood relatives are employees of CSIR-NML or CSIR or any other Laboratory/Institute of CSIR, in the Application Form.
- N. Disqualifications: No person, (a) who has entered into, or contracted a marriage with a person having a spouse living; or (b) who, having a spouse living has entered into, or contracted a marriage with any person shall be eligible for appointment to the council service provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from operation of this rule.
- O. Provisional candidature: Mere applying for the post against this advertisement does not necessarily amount to, either explicitly or implicitly, selection being actually made. The candidature for Skill Test as well as for Competitive Written Examination will be accepted only provisionally. The selection will be subject to fulfilling all the terms & conditions of the selection process and satisfying all the CSIR / Government of India instructions prevalent at a given point of time during various stages of selection process.
- P. Any further information regarding this advertisement like date, time and venue of tests, addendum/corrigendum or any variation in number of post/cancellation of post etc., will only be made available through CSIR-NML website https://nml.res.in. Therefore, candidates are advised to keep visiting regularly the website https://nml.res.in.
- Q. In case of any variation in Hindi version and English version of this advertisement, the English version shall prevail.
- R. NO INTERIM ENQUIRY OR CORRESPONDENCE WILL BE ENTERTAINED.

3. Age Limit & Relaxations:

- **A.** The upper age limit for the post is 27 years as on the last date of receipt of duly filled in Application Form in CSIR-NML.
- **B.** Age relaxation for Widows, Divorced Women and Women judicially separated from Husbands who are not remarried: the upper age limit is relaxable up to the age of 35 years. The persons claiming age relaxation under this sub-para would be required to submit following documents along with Application Form:

- I. In case of Widow: Death Certificate of her husband together with an Affidavit that she has not remarried since;
- II. In case of divorced Women and Women judicially separated from their husbands: A certified copy of the judgement / decree of the appropriate Court to prove the fact of divorce or the judicial separation, as the case may be, with an affidavit in respect of divorced Women that they have not remarried since.

C. Concession / relaxation to Persons with Benchmark Disability (PwBD)

- 1. The post is not identified suitable for the Persons with Benchmark Disability.
- **2.** The appointment in this post will be subject to the selected candidate being found medically fit in accordance with the standards of medical fitness as prescribed/decided by the Government of India / CSIR/CSIR-NML for such post.

D. Concession / relaxation in case of ex-servicemen

- 1. <u>Relaxation in upper age limit is available to ex-servicemen</u>: 03 years after deduction of the military service rendered form the actual age as on last date of receipt of duly filled in Application Form in CSIR-NML.
- 2. Ex-Servicemen who have already secured employment in civil side under Government in Group C &/or D posts on regular basis after availing of the benefits of reservation given to ex-servicemen for their re-employment are not eligible for fee concession.
- 3. The period of "Call up Service" of an Ex-serviceman in the Armed Forces shall also be treated as service rendered in the Armed Forces for purpose of age relaxation as per rules.
- 4. For any serviceman of the three Armed Forces of the Union to be treated as Ex-Serviceman for the purpose of securing the benefits of reservation, he/she must have already acquired, at the relevant time of submitting his/her application for the Post/Service the status of ex-servicemen or is in a position to establish his/her acquired entitlement by documentary evidence from the Competent Authority that he /she would complete specified term of engagement from the Armed Forces within the stipulated period of one year from the last date of receipt of duly filled in Application Form in CSIR-NML. Such candidates must also acquire the status of an ex-serviceman within the stipulated period of one year from the closing date of receipt of application.
- 5. The term ex-servicemen will apply to the persons who are defined as ex-servicemen in the Ex-servicemen (Re-employment in Civil Service and Posts) Rules, 1979, as amended from time to time and the instructions issued by the Government vide DoP&T OM No. 36012/3/2021-Estt. (Res.II) dated 27.02.2023, which provides, inter-alia, as under: -"Candidates working in the Armed Forces would become eligible for applying Civil posts only when he completes the prescribed period of Armed Forces Service within a year from of receiving application in connection Recruitment/Examination, etc., prescribed by the Competent Authority. Provided, when selection process takes more than one year, from the last date of receiving of applications, the candidate will not be declared ineligible under Ex-servicemen category only on the ground that the has got himself released from Armed forces after one year from the last date of receiving of application." Such candidates are also required to be in possession of the prescribed certificate and the Undertaking (as at Annexure-II and III of this advertisement), by the last date of receipt of duly filled in Application Form in CSIR-NML.

- 6. Explanation: An "ex-serviceman" means a person:
- 6.1. Who has served in any rank whether as a combatant or non-combatant in the Regular Army, Navy or Air Force of the Indian Union; and (i) who either has been retired or relieved or discharged from such service whether at his own request or being relieved by the employer after earning his pension; or (ii) who has been relieved from such service on medical grounds attributable to military service or circumstances beyond his control and awarded medical or other disability pension; or (iii). who has been released from such service as a result of reduction in establishment; or
- 6.2 Who has been released from such service after completing the specific period of engagement, otherwise than at his own request, or by way of dismissal, or discharge on account of misconduct or inefficiency and has been given a gratuity, and includes personnel of the Territorial Army namely, pension holders for continuous embodies service or broken spells of qualifying service; or
- 6.3 Personnel of the Army Postal Service who are part of Regular Army and retired from the Army Postal Service without reversion to their parent service with pension, or are released from the Army Postal service on medical grounds attributable to or aggravated by military service or circumstance beyond their control and awarded medial or other disability pension; or
- 6.4 Personnel, who were on deputation in Army Postal Service for more than six months prior to the 14th April, 1987; or
- 6.5 Gallantry award winners of the Armed forces in including personnel of Territorial Army; or
- 6.6 Ex-recruits boarded out or relieved on medical ground and granted medical disability pension. A matriculate Ex-Serviceman (Which includes an Ex-Serviceman, who has obtained the Indian Army Special Certificate of education or corresponding certificate in the Navy or the Air Force), who has put in not less than 15 years of service as on closing date of receipt of applications with the Armed Forces of the Union shall be considered eligible for appointment to the Group "C" posts against posts reserved for ESM only. Thus, those matriculate Ex-Servicemen who have not completed 15 years of service as on the closing date for receipt of applications are not eligible for these posts.
- 7. Ex-servicemen candidates are required to submit a copy of the certificate in the prescribed format signed by the specified authority valid for appointment of posts under the Central Government, along with the Application Form. The original certificates are to be produced as and when asked for by the Competent Authority, CSIR-NML for verification. The candidature/ appointment of the candidate shall remain provisional till the veracity of this certificate is established.
- **E.** Relaxations are permissible in upper age limit to any other categories as per instruction of GoI/CSIR.

4. How to Apply:

- A. Eligible and interested candidates are required to fill up the hard copy of the Application Form attached with this advertisement. No other mode of application will be considered.
- B. The application form is attached as Annexure-A to this advertisement which is required to be filled in by the applicant in his/her own handwriting. One Recent Passport size colour photograph must also be affixed at the designated place and signed across by the candidate in the application form. The photograph must not be more than three months old.
- C. Candidates are required to pay **application fee of Rs.500/-** (five hundred only) by clicking the link through <u>SB Collect</u> (kindly click on SBI Collect for online payment) (Govt/PSU/Courts DIRECTOR NML Payment Category Application fee Type of Application Regular Appointment]. The candidates belonging to SC/ST/PwBD/Women/CSIR Employees are exempted from payment of application fee. Those Ex-servicemen are also exempted who have not availed benefit of reservation available to ex-servicemen for securing employment in any other Government Department / PSU / Autonomous Body / Local Body etc. After making fee payment, the receipt generated must be preserved for future reference.
- D. Fee once paid will not be refunded on any account nor can it be held in reserve for any other recruitment or selection process.
- E. Only a single application will be entertained from each candidate. IN CASE A CANDIDATE SUBMITS MULTIPLE APPLICATIONS, ONLY THE LATEST DULY FILLED IN APPLICATION WILL BE CONSIDERED.
- F. Candidates should specifically note that the application received after the last date for any reason whatsoever (such as envelopes wrongly addressed, delivered elsewhere, postal delay etc.) will not be entertained by CSIR-NML.
- G. Incomplete application in any way like without signature, photograph and application fee (if applicable), without self-attested enclosures etc., will not be entertained and will be summarily rejected.
- H. In case of Universities/Institutes/Boards/Councils awarding CGPA/SGPA/OGPA grades etc., candidates are requested to convert the same into percentage based on the formula devised by the concerned University/Institute/Boards/Councils and mention accordingly in online application form at the specified places.
- I. Applications from candidates working in Government Departments /Autonomous Bodies /Public Sector Undertakings / Government Funded Research Agencies will be considered along with NO OBJECTION CERTIFICATE (NOC) from present employers. In case, the candidate could not attach the requisite NOC, he/she can enclose the self-attested copy of the request submitted by her/him to the present employer seeking NOC for her / his application against this advertisement. Such candidates must produce the requisite NOC as and when sought by CSIR-NML failing which his/her candidature will be terminated forthwith. The vigilance clearance should also be recorded in the said NOC.
- J. All further announcements regarding names of shortlisted candidates, date and time of tests etc. /other details pertaining to this recruitment process/updates/corrigendum/addendum etc. will be published/provided only on CSIR-NML official website https://www.nml.res.in from time to time.

- (c) In case of divorce of women: Certified copy of Divorce Decree and Deed Poll/ Affidavit duly sworn before the Oath Commissioner;
- (d) In other circumstances for change of name for both male and female: Deed Poll/Affidavit duly sworn before the Oath Commissioner and paper cuttings of two

leading daily newspapers in original (One daily newspaper should be of the area of applicant's permanent and present address or nearby area) and Gazette Notification.

6. <u>ACTION AGAINST CANDIDATES FOUND GUILTY OF MISCONDUCT/ USE OF UNFAIR MEANS</u>

Candidates are advised in their own interest that they should not furnish any particulars that are false, tampered with or fabricated and should not suppress any material information while filling-up the Application Form. At the time of skill test / written examination or in a subsequent selection procedure or even after selection/appointment to the post, if a candidate is (or has been) found guilty of;

- a. Using unfair means; or
- b. Impersonating or procuring impersonation by any person; or
- c. Misbehaving in the examination/ skill test venue or disclosing, publishing, reproducing, transmitting, storing or facilitating transmission and storage of contents of the test(s) or any information therein in whole or part thereof in any form or by any means, verbal or written, electronically or mechanically for any purpose; or
- d. Resorting to any irregular or improper means in connection with his/ her candidature; or
- e. Obtaining support for his/ her candidature by unfair means; or
- f. Carrying mobile phones or similar electronic devices of communication in the examination/ test venue, such a candidate may, in addition to rendering himself/ herself liable to criminal prosecution, be liable:
 - (i) to be disqualified from the examination for which he/ she is a candidate
 - (ii) to be debarred either permanently or for a specified period from any examination conducted by the CSIR or its Institute/Labs:
 - (iii) for termination of service, if he/ she already joined in Council service.
- g. The Competent Authority, CSIR-NML may also report the matter to Police/Investigating Agencies, as deemed fit and the Competent Authority may also take appropriate action to get the matter examined by the authorities/ forensic experts concerned.
