Terms & Conditions:

1. Application addressed to the Director, ICAR-NRC on Mithun, Medziphema, Nagaland should be produced at the time of interview.
2. The applicant must submit self-attested copies of certificates along with application form (as per the format annexed) and two passport size photographs. Applicant must bring with them all original documents at the time of interview for verification.
3. Age limit: The age limit is 21-45 years; relaxation to SC/ST/OBC/PH/ Ex-Serviceman/Women as per the Govt. of India instructions.
4. YP-I&II will not be entitled for any regular leave, but are allowed to have CL and RH from time to time, not exceeding 10 days in a year. They are full time workers and require to adhere to the administrative, financial and disciplinary regulations of ICAR-NRCM, regular attendance will be maintained.
5. Applicants with minimum eligibility need to appear for interview.

6. The candidate intending to attend the interview, if any of his/her near or distant relative is an employee of the ICAR/IARI, have to declare his/her name, designation, nature of duties, relationship in writing before the interview date.
7. The candidates are required to submit the application at the time of interview as per the format annexed.
8. All eligible candidates are requested to be present 60 minutes before scheduled time on the date of interview for necessary formalities.
9. Initially the period of engagement will be 31.3.2021, and extendable upto 1 year on need based of the organization and performance of the candidate.
10. Positions are purely temporary, time bound, non-regular and on co-terminus basis with the project. Appointment can be terminated on one month's notice.
11. The selected candidate shall have no legal right to claim regularization by absorption or otherwise against any regular posts or any further contractual engagement on termination of the Project.
12. The candidates reaching after the specified timing will not be entertained.
13. Canvassing in any form will disqualify the candidature.
14. No TA/DA will be paid for attending the interview.
15. YP-I at Sl.No-1 shall be engaged at Admn. Section, YP-I at Sl.No-2 shall be engaged at PME section and YP-II at Sl.No-3 shall be engaged at Animal health section.
