- 1. Application addressed to the Director, ICAR-NRC on Mithun, Medziphema, Nagaland should be produced at the time of interview.
- 2. The applicant must submit self-attested copies of certificates along with application form (as per the format annexed) and two passport size photographs. Applicant must bring with them all original documents at the time of interview for verification.
- 3. Age limit: The age limit is 21-45 years; relaxation to SC/ST/OBC/PH/ Ex-Serviceman/Women as per the Govt. of India instructions.
- 4. YP-I&II will not be entitled for any regular leave, but are allowed to have CL and RH from time to time, not exceeding 10 days in a year.
