- 4. Candidates claiming to belong to any particular category shall necessarily have a valid EWS/OBC/SC/ST certificate, as the case may be, from the Competent Authority. Upper age is relaxed by 5 years for SC/ST candidates, by 3 years for OBC candidates and by 5 years for candidates who had ordinarily been domiciled in the State of Jammu & Kashmir during the period 01.01.80 to 31.12.89. Relaxation of age to Ex-Serviceman will be as per Govt. guidelines. In terms of educational qualification, SC/ST candidates with pass marks are eligible to apply.
