**Experience Profile:** Minimum 04 years of post-qualification executive experience (excluding training/trainee period, if any) in Electrical Erection at site in the area of Substation and transmission erection work/ Electrical equipment (Like Motor, HT/LT Panel or switchgear/ HT/ LT Cable laying)/Relay and Protections/ Electrical Control System, HT/ LT Transformer in major infrastructure projects like Thermal/Hydro/Renewable/Nuclear power projects/Transmission/Refinery/Fertilizers/Petro chemicals/Steel/Cement.

#### B. Name of Post: Engineer (Mechanical Erection) -35 Posts

**Qualification:** B.E/B. Tech Degree in Mechanical/Production with at least 50% marks from a recognized University/Institution.

**Experience Profile:** Minimum 04 years of post-qualification executive experience (excluding training/trainee period, if any) in Mechanical Erection at site in the area of Pressure parts /Heavy equipment installations/material handling systems/Steam Turbine /Steam Generator in major infrastructure projects like Thermal/Hydro/Nuclear power projects/Refinery/Fertilizers/Petro chemicals/ Steel /Cement.

#### C. Name of Post: Engineer (Civil Construction) -35 Posts

**Qualification:** B.E/B. Tech Degree in Civil/Construction with at least 50% marks from a recognized University/Institution.

**Experience Profile:** Minimum 04 years of post-qualification executive experience (excluding training/trainee period) in Construction at site in the area of foundation works of vibratory structure/Piling work/high rise industrial structures/general Civil work in major infrastructure projects like Thermal/Hydro/Nuclear power projects/Refinery/Fertilizers/Petro chemicals/Steel/Cement.

**Upper Age Limit for all posts:** 35 years

#### General Conditions:

- Only Indian Nationals are eligible to apply.
- All qualifications should be from Universities / Institutions recognized and approved in India. In terms of educational qualification, only pass marks are required by SC/ST/PwBD candidates to apply.
- All computations of age/ experience requirement / qualification shall be done w.r.t. the last date of receipt of online application as mentioned in the advertisement. Where there is a vacancy identified for such category, total required experience will be relaxed by 01 year for SC/ST category.
- Candidates claiming to belong to any particular category shall necessarily have a valid EWS/OBC/SC/ST/Disability certificate, as

the case may be from the Competent Authority. Where there is vacancy identified for such category, upper age limit is relaxed by 5 years for SC/ST candidates, by 3 years for OBC candidates, by 10 years for PwBD candidates. Relaxation of age to Ex-Serviceman will be as per Govt. guidelines.

- Depending on the requirement, the Company reserves the right to cancel / restrict / curtail / enlarge the number of vacancies, if need so arises, without any further notice and without assigning any reason thereof.
- In-order to restrict the number of candidates for interview, if so required, the management reserves the right to conduct online screening/shortlisting/selection test or to raise the minimum eligibility standards/ criteria, as per the requirement.
- Posting shall be at any of the Stations/ Projects/ JVs/ Subsidiaries of NTPC. All posts are transferable at the sole discretion of the Management.
- While applying for the post, the applicant should ensure that he / she fulfills the eligibility and other norms mentioned above, as on the specified dates and that the particulars furnished are correct in all respects. In case it is detected at any stage of recruitment that a candidate does not fulfill the eligibility norms and / or that he / she has furnished any incorrect / false information or has suppressed any material fact(s), his/her candidature will stand automatically cancelled. If any of the above shortcoming(s) is / are detected even after appointment his / her services are liable to be terminated without any notice. Canvassing in any form shall disqualify the candidate.

No other means/ mode of application shall be accepted. Candidates are required to possess a valid email ID. NTPC will not be responsible for bouncing back of any email sent to the candidates. Candidate belonging to General/EWS/OBC category is required to pay a non-refundable application fee of Rs. 300/-. The SC/ST/PwBD/XSM category & female candidates need not pay the application fee.

**Payment in offline mode:** State Bank of India has been authorized to collect the application fee, in a specially opened account (A/C No. 30987919993) at CAG branch, New Delhi (Code: 09996), on behalf of NTPC. Candidate has to approach the nearby SBI branch with a printout of the "pay-in-slip" which is available on the application portal. The pay-in-slip printed from the portal should only be used for depositing the fee for proper crediting of amount in the allocated account. On receipt of the money, the bank will issue a unique Journal Number and a Branch Code of the bank collecting the money. This journal number and the branch code are to be filled up by the candidate during online application. NTPC will not be responsible, in case a candidate deposits the fee in wrong account.

**Payment in online mode:** Candidates also have the option to pay the fees online (through Net banking / Debit Card / Credit Card). The online payment option will be available in the online application form.

Fee once paid will not be refunded under any circumstances. Candidates are therefore requested to verify their eligibility criteria before paying the application fee. **After applying online, candidate is required to download the application slip generated by the system with unique application number.** Copy of application slip may be retained by the candidate for future reference. No document is required to be sent to us by post.
