**Experience Requirement:** Minimum 02 years of working experience in one or more of the areas related to MSSQL Server, Power BI, Python, R, SAP or OS/soft PI, data manipulation and analysis using libraries and frameworks like Pandas, NumPy, and Jupyter. Candidates with experience in machine learning and deep learning methodologies and development of AI/machine learning based models using appropriate algorithms will be preferred.
