Abbreviations Used: PwBD - Persons with Benchmark Disabilities; Category C - Locomotors disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy; Category D - Autism, intellectual disability, specific learning disability and mental illness; Category E - Multiple disabilities from amongst persons under clauses (c) to (d); OA, OL, BL, OAL, LC, DW, AAV - One Arm, One Leg, Both Legs, One Arm & One Leg, Leprosy Cured, Dwarfism, Acid Attack Victims; SLD = Specifics learning disability.

- i. The post is identified for PwBDs as per column 7 of the above table so eligible PwBD candidates may also apply. However the same is not reserved.
- ii. There is no maximum age limit for the advertised post.
- iii. The Candidate must possess the essential prescribed qualifications as well as a valid registration with the concerned statutory authority (wherever applicable) on the date of interview. Experience is desirable.
- iv. Nomenclature of qualifications shall be as prescribed by UGC/ Medical Council of India.
- v. The degree of MBBS should compulsorily be registered with Medical Council of India / State Medical Council.

- vi. Candidates who have acquired MBBS/ MD from a foreign university, such MBBS/ MD or equivalent qualification in medical discipline shall be allowed which are recognized and approved by Medical Council of India (MCI).
- vii. Candidates seeking reservation under OBC category, shall have to produce a certificate in the prescribed proforma ONLY, meant for appointment to posts under the Government of India, from the designated authority indicating clearly the candidate's caste/community, the Act/Order under which it is recognized as OBC and the Village/Town the candidate is ordinarily a resident of. They must also ensure that the name of their caste/community and its spelling in their caste/community certificate should be exactly as mentioned in the lists notified by the central government from time to time (for OBC category, list of castes recognized by the Govt. of India as OBC castes in the central list is available on the site http://www.ncbc.nic.in . A certificate containing any variation in the caste/community name will not be accepted. Further, the OBC certificate should also clearly indicate that the candidate does not belong to creamy layer as defined by the Government of India for applying to posts and services under the Central Government and certificate should have been issued on or after 01.04.2024 by the competent authority.
- viii. The OBC claim of a candidate will be determined in relation to the State (or part of the State) to which his/her father originally belongs. A candidate who has migrated from one State (or part of the State) to another should, therefore, produce an OBC certificate which should have been issued to him/her based on his/her father's OBC certificate from the State to which he (father) originally belongs.
- ix. Prescribed format of the certificate for OBC /PwBD for employment in government undertaking is down- loadable from ONGC's website www.ongcindia.com.

B. How to Apply

- b) Candidates need to download an application attached as **Annexure-I** and bring it duly filled in and affixed recent passport size photograph at the time of Interview along with following documents in original and 01 set of Xerox copy:
 - i. Duly signed and filled application format at **Annexure I**.

- ii. Photo identity proof like PAN Card, Aadhar card, Passport, Driving License. Voter I Card.
- iii. Passport size photograph.
- iv. Class 10th Board Certificate containing Date of Birth (DOB). No other proof for determining Date of Birth shall be considered.
- v. Consolidated Marksheet of MBBS Degree
- vi. M.B.B.S. Degree.
- vii. Degree and marksheets for MD / MS (If any)
- viii. Internship Completion Certificate.
- ix. Valid Registration Certificate with the statutory registration Council like MCI /state etc.
- x. OBC (NCL) Certificate (Should be in central government format)
- xi. PwBD Certificate (if applicable). Certificate of benchmark disability should be issued as per the guidelines of RPwBD Act 2016.
- xii. Proof of Higher Qualification (if any) Mark sheet of all semesters and Degree/ Diploma Certificate.
- xiii. Experience Certificate (if any).
- xiv. No Objection Certificate (NOC) from existing employer, if any (in case the candidate is a regular employee in a Govt. organisation / PSU).
- xv. Valid proof of change of name (in case, applicable).
- c) No Candidates will be allowed to appear for Walk-In Interview after the scheduled time. Interview shall start immediately after registration.
- d) Candidates may please ensure that they are fulfilling all the requisite criteria for the advertised post prior to coming for the interview failing which, their candidature is liable to be rejected/ cancelled at any stage of the recruitment process or even after selection.
- **C. Selection Criteria**: Following weightages shall be assigned to different parameters in the selection process:

Note:

- i. The breakup of 10 marks for such higher qualification shall be considered as follows:
 - a) 5 marks shall be given to a Post-Graduation (PG) degree (e.g. MD/MS).
 - The PG qualification in Anesthesiology/Dermatology, Venereology and Leprosy/Family Medicine/General Medicine/Pediatrics/Palliative Medicine/Pathology/Psychiatry/Radio-Diagnosis / Radiology/Tuberculosis and Respiratory diseases/Emergency and

Critical care/Ear, Nose and Throat/General Surgery/Ophthalmology/Orthopedics /Pulmonary and Sleep disorders/Traumatology & Surgery/Otorhinolaryngology will be eligible for additional 5 marks for the post of Contract Medical Officer –Field duty. Other qualifications such as PG in Biochemistry/Forensic Medicine/Microbiology/ Pharmacology/ Physical Medicine and Rehabilitation/Physiology etc will not be eligible for additional 5 marks.

- b) Further additional 5 marks shall be given to higher qualification acquired in the relevant field after Post-Graduation (e.g. M.Ch/ DM).
- ii. The qualifications considered for granting additional marks shall need to be in line for example an MBA in Hospital Administration shall not be considered as an inline qualifications where M.B.B.S. is the essential qualification.
- iii. Qualifying marks in the interview shall be 18 marks for OBC.

D. Finalization of Merit List

- i. Candidates who qualify in the interview shall be empanelled in the Merit List.
- ii. Offer of appointment shall be issued to the candidates based on their relative rank in the Merit List prepared on the sum total of marks scored by the candidate in qualification and interview.
- iii. In case of a tie in the total marks scored between two candidates, then the candidate who scores more marks in interview shall be considered senior. In case there too the marks are equal then the candidate who is older in age shall be considered senior for issue of offer of appointment.
- iv. Appointment of selected candidates will be subject to their passing the company's Medical Examination as per standards laid down under ONGC Medical Examination of Employees Rules, 1996. Details of the rules are available on ONGC's Website at www.ongcindia.com
