ENGAGEMENT OF DOCTOR ON CONTRACT BASIS AT ASSAM ASSET

Oil and Natural Gas Corporation Limited (ONGC), a “Maharatna” Public Sector Enterprise, and India’s flagship energy major engaged in Exploration and Production of Oil and Gas in India and abroad, intends to engage Doctors/ Specialists on **contract basis** at ONGC Hospital Assam Asset on a consolidated honorarium.

Interested and eligible candidates are invited to appear for Interview for engagement on Contract Basis (from the date of engagement) till **30.06. 2024** for the following Position:

Note:

- i. There is no maximum age limit for eligibility.
- ii. The Candidate must possess the essential prescribed qualifications as well as a valid registration with the concerned statutory authority (wherever applicable) on or before the last date of submitting application. Experience is desirable for posts.
- iii. Nomenclature of qualifications shall be as prescribed by UGC/ Medical Council of India.
- iv. The degree of MBBS / MD / MS should compulsorily be registered with Medical Council of India / State.
- v. Qualifications equivalent to the one prescribed in this advertisement including qualifications acquired from a foreign university will be accepted, if recognized and approved by Medical Council of India.
- vi. Where the posts specified in this advertisement are not reserved for any category (ies), a reserved category candidate can also apply provided he/she fulfills the criteria specified for the post. However he/she shall be treated at par with unreserved category candidates.

B. How to Apply

- a) Candidates need to visit www.ongcindia.com to register on our Registration web link. The registration link shall remain open from **26.07.2023 to 03.08.2023**.
- b) Candidates will be informed about interview with details of date, time and venue etc. through email / SMS.
- c) All communications with the candidate shall be through SMS/ e-mail.
- d) Candidates need to mail the following documents in pdf/jpeg/jpg format (mentioning their name and name of document) to email id – recruitmentassam@ongc.co.in after completing registration:
 - i. Duly signed and filled application format at **Annexure I**.
 - ii. Scanned copy of any one Photo identity proof like PAN Card, Aadhar card, Passport, Driving License. Voter I Card.
 - iii. Scanned copy of Passport size photograph in jpg/ jpeg format. (upto 200 kb size)
 - iv. Class 10th Board Certificate containing Date of Birth (DOB). No other proof for determining Date of Birth shall be considered.

- v. Consolidated Marksheet of MBBS Degree
- vi. M.B.B.S. Degree.
- vii. Degree and marksheets for MS (ENT).
- viii. Internship Completion Certificate.
- ix. Valid Registration Certificate with the statutory registration Council like MCI etc.
- x. Proof of Higher Qualification (if any) - Mark sheet of all semesters and Degree/ Diploma Certificate.
- xi. Experience Certificate (if any).
- xii. No Objection Certificate (NOC) from existing employer, if any (in case the candidate is a regular employee in a Govt. organisation / PSU).
- xiii. Valid proof of change of name (in case, applicable).

- e) Candidates will be required to bring the above documents in original and report for interview as per date, time and venue intimated. The interviews will be held preferably through online method such as Zoom, Webex, Google Meet, MS Team etc, however depending on situation, candidates may be asked to appear in-person (physical mode) at Assam Asset , Nazira.
- f) Candidates may please ensure that they are fulfilling all the requisite criteria prior to applying for the post failing which, their candidature is liable to be rejected/ cancelled at any stage of the recruitment process or even after selection.

C. Selection Criteria: Following weightages shall be assigned to different parameters in the selection process:

Qualification	70 marks (60 marks for essential qualification & up to 10 marks for relevant higher qualifications)
Interview	30 marks
TOTAL	100 marks

Note:

- i. The breakup of 10 marks for such higher qualification shall be considered as follows:
 - a) Where a Master’s degree is the minimum essential qualification for example MD / MS (Anesthesia) for the post of Contract Medical Officer –Anesthesia, minimum 60 marks may be given for the essential qualification. Additional 10 marks shall be given to a Post Master’s qualification in the relevant field (e.g. M.Ch/ DM).
- ii. The qualifications considered for granting additional marks shall need to be in line for example an MBA in Hospital Administration shall not be considered as an inline qualifications where M.B.B.S. is the essential qualification.

D. Qualifying marks in the interview shall be 18 marks for UR category.

E. Finalization of Merit List

- i. Candidates who qualify in the interview shall be empanelled in the Merit List.
- ii. Offer of appointment shall be issued to the candidates based on their relative rank in the Merit List prepared on the sum total of marks scored by the candidate in qualification and interview.
- iii. In case of a tie in the total marks scored between two candidates, then the candidate who scores more marks in interview shall be considered senior. In case there too the marks are equal then the candidate who is older in age shall be considered senior for issue of offer of appointment.

F. Appointment of selected candidates will be **subject to their passing the company’s Medical Examination** as per standards laid down under ONGC Medical Examination of Employees Rules, 1996. Details of the rules are available on ONGC’s Website at www.ongcindia.com.

I. General Instructions:

- Engagement is purely temporary on contract basis for a period up to 30.06.2024. Contract tenure will commence from the date of joining.
- Engagement on contract would be subject to medical fitness.
- Selected candidates shall be required to sign a contract agreement as per the terms and conditions of ONGC. The contract shall end on expiry of the prescribed period and no separate notice shall be required to be given.
- The contract can be terminated at any time by giving one month's notice, by either side.
- No claim for regular employment in ONGC, by virtue of this contractual engagement, shall be entertained at any stage.
- Selected candidates will be paid consolidated monthly remuneration as mentioned above.
- On successful completion of one year period an annual increase at following rates may be considered:
