We are looking for dynamic professionals purely on Contract basis from Open Market for the following posts, for which applications are invited from Indian citizens. The contract period will be initially one year and extendable based on work requirements and performance.

Electronics or equivalent.  b). <u>Contractual Engineer/Civil</u> - Full-time Bachelor's degree in Civil Engineering.
Minimum experience	a) <u>Contractual Engineer/ Signaling and Telecom</u> - Candidates should have total post-qualification experience of minimum 02 years of working in Signal & Telecommunication construction projects dealing with installation/ testing and commissioning of SSI/EI/RRI/PI of indoor and outdoor of Signal & Telecommunication gears for Indian Railways, Metros, Railway sidings/ PSU Railway Sidings/ Private sector Railway sidings.  b) <u>Contractual Engineer/ Civil</u> - Candidates should have a minimum of 2 years post-qualification experience, in the field of project management/ supervision/ Execution of infrastructure Projects in the fields of Railways/ Metro/ Highway/ Bridges/ Ports/ Airports/ Building/ Industrial Sheds/ Tracks, etc.

**5. Documents Required to Be Attached with the Application Form and Verification:** The candidates should attach self-attested copies of the following documents with the application and should also produce these in original, if they are called for interview:

- Matriculation Certifications (for age proof).
- Certificates and mark-sheets in support of the required educational/professional qualifications.
- Certificates in proof of experience, clearly indicating the length and field of

experience.

- d) Caste certificates (in case applicant belongs to SC/ OBC-NCL).
- e) Copy of CV with signed photograph thereon.
- f) Copy of the appointment letter in support of appointment to the post in the organization in which currently working along with valid Identity Card/ Current pay slip issued by the company.
- g) Photo I.D. Proof and address proof (Passport/ Aadhaar Card/ Driving License/ PAN Card/ Voter ID Card) issued by Central/State Govt.
- h) “No Objection Certificate” if the candidate is working in any Govt./PSU, attached or subordinate organization, or any public body substantially funded by the Govt.

NB: The onus is on the candidates to prove with valid documents that all the information submitted by them in the application is true.

6. **Schemes of selections:**

- a) The selection process will consist of an interview followed by a medical examination.
- b) Final empanelment will be subject to the candidate being found medically fit. The medical examination will be conducted by a medical authority designated by RailTel Corporation of India to assess the candidate's fitness for duties associated with the post. Candidates who do not meet the prescribed medical standards will not be considered for appointment.

7. **How to apply:** Candidates must apply offline. 8. Other terms and conditions:

- a. The decision of RailTel regarding all aspects of the recruitment process—including acceptance or rejection of applications, conduct of examination/interview, and final selection—shall be final and binding. RailTel reserves the right to alter or modify any condition mentioned in this vacancy notice or any related process as deemed necessary due to unforeseen circumstances or administrative reasons.
- b. In case of any legal dispute, the jurisdiction shall be Kolkata.
- c. RailTel Corporation will not be responsible for any inadvertent errors in this vacancy notice and reserves the right to correct such errors.
- d. Requests for changes to the email ID or address submitted with the application will not be entertained.
- e. Travelling Expenses: No travelling expenses will be paid to the candidates for appearing in the screening/interview.
- f. Terms & Tenure of Engagement: Engagement is contractual, initially for one year from the date of joining, and may be extended based on project requirements and performance. It may be terminated earlier due to non-availability of work, unsatisfactory performance, or administrative reasons, at the discretion of the Competent Authority.
- g. Resignation: A notice period of three months shall be mandatory prior to resignation from RailTel Corporation. Serving such notice will not absolve the executive from financial or other obligations under the service agreement. In case of shorter Notice, they shall be liable to pay an amount equivalent to 03 months gross salary.
- h. Service Agreement: Selected candidates will be required to execute a service agreement at the time of appointment, committing to serve the organization for a period of one year. In case of failure to complete the said period, they shall be liable to pay an amount equivalent to three months' gross salary. In addition to notice period required in case of resignation.
- i. Background Check: Selection/appointment shall be provisional, subject to verification of character, antecedents, caste certificate, and other submitted documents, as well as fulfilment of medical and other conditions applicable to appointments under the Central Government/PSUs.
