- 2. The engagement is subject to periodic evaluation of the service provider and if, on such evaluation the services are not found to be satisfactory, the contract will be terminated with one-month notice.

- 5. The Selected Consultant shall will be required to visit the Centre on a regular basis. Monthly fee will be payable upon meeting the minimum service requirements decided by the Centre.
- 6. The contract is for consultancy services and will not, in any case, be considered as an employment contract with the Centre.
