- 11. The sportspersons appointed against Sports Quota through Open Advertisement will undergo probation periods of two years after completion of training, if any.

- 13. The sportspersons appointed through Open Advertisement Quota, shall fulfill the minimum medical norms for the post, for which they will be appointed.
