The engagement of successful candidates will be on **short-term** contract basis (and not on regular basis) initially for a period for upto one year extendable subject to review of candidate's performance and the requirement of the RLDA Projects. **It is to be noted by all applicants that the above vacancy is purely temporary and contractual in nature and selection on these posts will not confer any right whatsoever for employment in RLDA.**

- i. Desirable/Preferred Skills: Building Construction works.
- ii. General Condition on Qualification: All qualifications must be from a recognized University/Institution approved by AICTE/UGC/Government of India and only full-time regular courses shall be considered.
- iii. Experience Counting: Experience shall be counted after acquiring the minimum prescribed qualification.
- iv. Crucial Date for Eligibility: (Closing date of the notification).
- v. Note on Experience: Internship/Apprenticeship/Training/Teaching/Academic/Freelancing experience shall not be treated as qualifying experience.

2. Remuneration

- i. Monthly consolidated remuneration @ Rs.76,000/- (all inclusive).
- ii. Statutory deductions such as Income Tax, Professional Tax etc. shall be made as applicable.
- iii. Employer's contribution towards EPF shall form part of the CTC.

3. Age Limit (as on 22.05.2026)

- i. Maximum age: 45 years as on 22.05.2026 (Closing date of the notification).
- ii. Age relaxation shall be applicable as per Government of India guidelines for SC / ST/OBC (NCL)/Ex-Servicemen.
- iii. If a candidate is eligible for age relaxation on two or more grounds as mentioned in Annexure-II, only the highest admissible age relaxation shall be applicable.

4. Application Fee

5. Selection Procedure

- i. Selection will be made on the basis of last drawn Gross Salary, relevant work experience in Civil Construction/Projects supervision (minimum 02 years), percentage marks obtained in B.Tech Civil Engineering/Electrical Engineering and interview. Weightage will also be given for M.Tech qualification. Weightage for candidates directly worked in Indian Railways/Central PSU/State PSU/Govt Dept for a minimum cumulative period of 01(one) year.
- ii. RLDA reserves the right to assess candidates as per organizational and project requirements.
- iii. Engagement shall be purely on contract basis for an initial period of upto one (01) year extendable as per project requirement and satisfactory performance. In

case of further requirement of RLDA, the agreement for engagement can be extended/renewed.

- iv. The engagement shall automatically cease on expiry of the contract period unless extended by RLDA.
- v. One-month advance notice shall be required from either side for termination of contract.

6. General Information/Instructions

- i. **Candidates shall furnish duly filled application form alongwith self-attested copies of certificates viz. Educational qualification, Experience Certificate, Caste/Category, Identity Proof, Address Certificate etc. on the e-mail address specified and also to the RLDA address.**
- ii. In case of total number of applicants are high, Authority will short list the applicants on the basis of selection criteria and only the shortlisted applicants will be called/allowed for the interview.
- iii. Candidates working in Government/PSU/Autonomous bodies shall give an undertaking regarding no dues or produce No Objection Certificate (NOC) from their employer at the time of interview. However
- iv. Engagement on contract basis shall not confer any right for regular appointment or continuation in RLDA.
- v. Candidature shall be provisional and subject to verification of documents and eligibility.
- vi. For availing reservation, EWS, SC, ST & OBC-NCL candidates should furnish necessary certificate while filling the application form in the standard prescribed format.

Candidates belonging to the OBC (Non-Creamy Layer) category must submit a caste certificate issued by the Competent Authority in the format prescribed for appointments under the Government of India must be issued during the current financial year or 2025-26 clearly indicating that the candidate does not belong to the creamy layer.
- viii. In the case of EWS candidates, an Income and Asset Certificate for 2024-25 issued by the Competent Authority during the current financial year only shall be accepted as valid proof for availing reservation under the EWS category.
- ix. In case the Caste/Category certificate is issued in a language other than Hindi or English, the candidate shall be required to produce a certified translation of the same in Hindi or English at the time of Interview/Document Verification/Joining, as applicable.

- x. Selected candidates will be posted in the RLDA project at any location as per its requirement.
