Dr. Rajendra Prasad Central Agricultural University, Pusa is advertising two (02) posts of "**Test Engineer**", purely temporary and on contract basis under **Farm Machinery Testing Centre (FMTC)**, College of Agricultural Engineering and Technology (CAET), RPCAU, Pusa.

Eligible candidates may attend the walk-in-interview on 08/08/2025 at 09:00 AM in the Office Chamber of Dean, CAET, RPCAU, Pusa, Samastipur, Bihar.

The candidates should bring the print out of their application duly filled in the prescribed proforma (Attached) along with original and self-attested copies of all necessary documents related to date of birth, educational qualifications and experience certificate etc.

Applicants should report positively before half an hour to the prescribed time at the said venue.

Terms & Conditions

- 1. Above position is purely temporary and will be filled on contractual basis with co-terminus with the project. **The post will be offered as per the University norms.**
- 2. The University reserves the right to decide upon criteria of eligibility/increase/decrease the number of post/alter any conditions at any point of time or not to fill up any of the posts advertised in case of non-availability of any suitable candidate or due to any other reasons without adducing any reason thereof.
- 3. No TA/DA will be borne by the University to attend the interview.
- 4. Canvassing in any form will lead to disqualification and if shortlisted, the candidate will not be interviewed by the Selection Committee.
- 5. Selected candidates will not be entitled to claim for regular appointments/absorption either in the University. Non-maintenance of the discipline and failure to perform the assigned duties will make the selected candidate liable for termination during the appointment period as per rules.

- 6. **No Objection Certificate** from the employer shall be produced in case the candidate is employed elsewhere.
- 7. Candidates will be shortlisted for Interview on the basis of their academic qualification, experience, publication, achievements/awards etc. submitted by the candidates with the duly filled application form and considering relevant criteria as per job requirement of the position. Only the shortlisted candidates after screening procedure will be allowed to appear in the interview. Since it is a walk-in-interview process so no separate communication will be made to the candidates and list of qualified candidates will be released on the day of walk-in-interview.
- 8. Candidate fulfilling the essential Qualifications and eligibilities criteria only need to apply for this post. The self-attested document furnished by the selected candidate(s) with his/her application form shall be verified from original documents. It is mandatory to produce the documents before the Committee; any relaxation in this regard will not be accepted.
- 9. If the interview is not conducted as scheduled due to any unavoidable circumstances, then you may have to stay for the next day for interview, without any TA/DA claim.
- 10. Candidates are also requested to bring 05 copies of your updated duly signed short CV (not more than 02 pages) at the time of interview.
- 11. Failing to comply on above points, candidate may be debarred from interview.
- 12. Canvassing in any form or bringing any influence will be treated as disqualification.
- 13. In case of any disputes, it will be resolved in the jurisdiction of Patna High Court only.
- 14. Candidates are advised to fill their application form carefully such as Name, Father's name, Date of Birth, Category, Qualification, e-mail & mobile number and other details, it is mandatory to enclose/attach essential documents along with recent **two (2) passport size photos (not more than 06-months-old from the date of advertisement) & Signature**. Candidate will be solely responsible for any mistake in the data of application form and no correspondence will be entertained in this regard. The decision of the University in this regard would be final and liable on the candidates.
- 15. All the relevant columns of the application form should be filled in.
- 16. Candidate is required to clearly mention the post name on the application form. Failing to the same, his/her candidature will not be considered & candidate would be solely responsible for that.
- 17. Incomplete and Unsigned applications will not be considered and will be **REJECTED**.
- 18. Qualifications/eligibility conditions, age and other documents will be determined as on closing date with due approval of the Competent Authority.
