1. No. to be engaged on contractual basis : 01 (One)
2. Period of engagement : 03 (Three) years.
3. Consolidated Fee : Rs.65,000/- per month
4. Other Benefits :
 - Rent free accommodation upto 2 BR quarters of SAIL at Rourkela
 - Post-paid SIM under CUG including call charges of Rs.350/- per month
 - Free medical treatment for self & spouse
 - 15 days Casual Leave per year.

5. **ELIGIBILITY CRITERIA:**

- a) Age : Maximum age 62 years as on 07/10/2023
- b) Essential Qualification : 1. BE or B. Tech / B.Sc. (Aviation) / B.Sc. (PCM) (Regular course) from recognized Indian university.

OR

Commissioned / Senior Non-commissioned officers of IAF and equivalent officers of other defense / paramilitary forces (Aviation Wing) with ATC / SFSIO (IAF) and equivalent qualification of other defense / paramilitary forces (Aviation Wing).

2. Should have a valid Safety Management System (SMS) certificate on aviation. Preference will be given to applicants with better additional qualifications.
- c) Essential Experience : Minimum 1 year experience (Civil or Military) in Safety Management System on Aviation/ Airport Safety / Flight Safety / Air Traffic Control. Preference will be given to the applicants having working experience as Airport Safety Manager in any Airport.
6. Nature of job to be performed :
 - Ensure that the day to day Safety Management is performed in the department.
 - Assist and contribute to the Safety Committee
 - Prepare Safety Report and analysis of trends and analyze key risk areas for the unit, they are assigned
 - Advise the SMS (Safety Management System) Manager as to possible solutions / improvements
 - Ensure compliance with existing rules and regulations of Regulatory bodies viz. DGCA / BCAS etc.
 - To Assist in preparation of different Airport Manuals / Documents pertaining to Licensing etc., along with providing assistance to the Airport Director in different jobs as and when required.
7. Methodology of Selection : Walk-in Interview
8. Termination of Service : Can be terminated by giving 01 month's notice by either side.
9. Application Fee : No application fee shall be charged from the candidates appearing in the interview.
