# 2. Who can apply

Doctors who are registered with Medical Council of India (MCI)/ National Medical Commission (NMC)/ State Medical Council (SMC) or having valid medical Practitioner license and enrolled in the State Register or National Register are only be eligible for engagement.

The Consultants (Doctors in Medical Disciplines) having relevant post qualification work experience shall be given preference. The essential qualification and work experience, if any, shall be taken into account as on the date of advertisement.

Ex-employees of SAIL and non-SAIL ex-employees who have been separated through Voluntary Retirement shall not be considered for engagement. Ex-employee applicants shall have to provide self-declaration in this regard.

3. **Tenure of engagement:** 

a. The initial tenure of engagement of Consultants (Doctors in Medical Disciplines) would be for a period of one year from the date of joining, which can be further extended for a period of one year at the discretion of the Company.

b. The maximum period for engagement under the same would not be more than three (03) years. However, there will be no bar on re-engagement.

c. The tenure of engagement shall be subject to the upper age limit of 70 years. However, the Consultants (Doctors in Medical Disciplines) to be engaged should be fit to perform duties.

d. The performance of the Consultants (Doctors in Medical Disciplines) so engaged will be periodically reviewed on annual basis and the tenure can be extended subject to satisfactory performance.

## 5. Working Hours and Leave

a. The above monthly remuneration rates shall be applicable for engagement for a minimum 8 hours a day for six days in a week or 48 hours a week. The monthly rate shall not exceed the maximum prescribed limit of the respective category.

- b) No PF/Gratuity or any other benefit unless and until specified /indicated shall be payable.
- c) The Consultants (Doctors in Medical Disciplines) engaged shall be eligible for Maternity leave as per Maternity Benefit Act, 1961 subject to fulfillment of conditions stipulated in the Maternity Benefit Act, 1961.

# 9. Termination of Engagement:

If there is evidence of the Consultants (Doctors in Medical Disciplines) being medically unfit and which is likely to continue for a considerable period of time and he/she cannot discharge his/her normal duty. The decision of the Company regarding fitness or otherwise shall be conclusive and binding on the Consultants (Doctors in Medical Disciplines) so engaged.
- b. In case of poor performance.
- c. In case of moral turpitude, conviction by a Court of Law, insolvency, loss of license to practice, grave misconduct or financial irregularity.
