Who can apply	a) Interested & eligible candidates having requisite qualifications can walk-in for interview at the scheduled date, time & venue. b) Ex-employees of SAIL Plants/ Units and other PSUs/ Govt. can also apply, provided, they have not separated by opting for voluntary retirement. The ex-employee will have to provide self-certificate in this regard.				
4.	Age limit	64 years as on date of advertisement i.e. 29.04.2026 The upper age limit for engagement under this Scheme is 65 years. However, the consultants to be engaged should be medically fit to perform his/her duties.				
5.	Tenure of engagement	a) The initial tenure of engagement of Consultants (Sports Coach) would be for a period of one (01) year or till attaining the age of 65 years whichever is earlier, which can be further extended for a period of one (01) year at the discretion of the Company. The maximum period for engagement under the same would not be more than 3 years. However, there will be no bar on re-engagement. The tenure of engagement shall be subject to the upper age limit as prescribed above. b) The performance of the Consultant (Sports Coach) so engaged will be reviewed on annual basis and the tenure can be curtailed or extended, subject to satisfactory performance.

		*Coaching experience should be preferably more than 15 years in respective sports discipline as well as depending upon specific certification/license as required in identified sports discipline. The essential qualification and work experience, if any, shall be taken into account as on the date of advertisement i.e. 29.04.2026				
7.	Job Description	The Consultants (Sports Coach) shall be engaged for Coaching/ Training the cadets of SAIL Football Academy, Bokaro/SAIL Day Boarding Volleyball Center, Shibutand, Bokaro. The Consultants (Sports Coach) shall also be utilized for office / field works of Sports Department as & when required and their services shall be utilized in organizing any sports events by BSL. The Consultants shall perform work as entrusted to them for 6 hours a day for 6 days in a week. Further, if engagement is for less or more than 6 hours per day, the rates may be pro-rated accordingly.				
8.	Other Benefits	a) In case of ex-employees of SAIL, the allotted Company Accommodation may be retained during their engagement period with rent and other charges for electricity & water charges etc. to be charged for that category of accommodation. b) Other Non-SAIL ex-employees engaged as Consultants (Sports Coach) under the Scheme can be provided Company accommodation (2 BHK or equivalent categories) on payment basis, if desired, subject to availability. The rent and other charges like electricity, water etc. shall be as applicable for that category of quarter for SAIL				

	d) In case of ex-employee of SAIL, the medical benefits as applicable/ available for ex-employees will continue. In other cases, the medical benefits shall be available for self only at the unit hospital without any referral. e) The consultants engaged under the Scheme will be eligible to get 10 days leave in a year subject to prior approval. f) The Consultants (Sports Coach) engaged shall be provided TA/DA as per the entitlement to the lowest category of Executive cadre under the "SAIL Travelling Allowance (TA) Rules-2021". For ex-employees of SAIL the same shall be provided as per the entitlement of the grade in which the employee has superannuated as per the extant rules.
9.	Selection Process
	a) Through "Walk-in-Interview" followed by a medical screening. b) Engagement will start immediately after the selection of the candidate is completed and orders are issued for engagement. c) Candidates responding to the advertisement for "ENGAGEMENT OF CONSULTANTS (SPORTS COACH) IN BOKARO STEEL PLANT" will have to download the Application Form (Annexure I) and submit the duly-filled application form along with the listed supporting documents at the time of 'Walk-in-Interview'. No other mode of application will be accepted.

GENERAL CONDITIONS:

- Candidate must be an Indian national possessing requisite qualification.
- Eligible & interested candidates may attend the walk in interview on the above date, time & venue along with following documents (original + 1 set of self-attested photocopies):
 - Filled in application format (Annexure-I) with one additional passport size recent colour photograph.
 - Pass certificate & mark sheets for educational qualification.
 - Experience Certificate (as applicable) showing relevant post qualification experience from the employer (In case of retired employees, service certificate issued by the parent organization should be given.)
 - Certificate pertaining to Sports accreditation/ achievement/ participation in National/ International sports events/ games representing Indian State/ Country.
 - Proof of date of birth (Matriculation certificate of recognized Board).
 - Photo Identity Proof (Voter ID/ PAN/ Aadhar Card/ Driving License/ Passport).
- All certificates & documents in support of eligibility will be verified only during 'Walk-in-Interview' and any candidate who fails to produce the same will not be allowed to appear at the interview. Therefore candidates are required to ensure their eligibility before appearing in the 'Walk-in-Interview'.
- The contractual engagement under the scheme can be terminated by giving one months' notice by either party. However, in case of poor performance, moral turpitude, conviction by Court of Law, insolvency, loss of licence to practice, grave misconduct of financial irregularity and if there is evidence of the Consultants (Sports Coach) being medically unfit and likely to continue for a considerable period of time and cannot discharge normal duty hours, the engagement can be terminated by the company.
- No TA/ DA will be paid for attending 'Walk-in-Interview' / selection process.
- The engagement is purely of temporary nature and is not to be construed as giving rise to any right of regular appointment in BSL in any manner whatsoever.
- SAIL, BSL reserves the sole authority to consider the cases as per its rules and decision of BSL in this regard shall be firm & binding.
- SAIL, BSL reserves the right to reject any application or cancel the candidature or the whole process of interview or engage less than the numbers of doctors indicated above, without assigning any reason thereof and no enquiry or correspondence will be entertained in this connection.
