Reservation for Economically Weaker Section (EWS) is governed by Office Memorandum no. 36039/1/2019-Estt (Res) dated 31.10.2019 of Department of Personnel & Training, Ministry of Personnel, Public Grievance & Pensions, Government of India.

Benefit of reservation under EWS category can be availed upon production of an 'Income and Asset Certificate' issued by a Competent Authority on the format prescribed by Government of India based on **gross annual income for the financial year 2025-26 and valid for the year 2026-27** as per the extant DoPT guidelines. **No request for extension of time for production of 'Income & Asset Certificate'** shall be entertained and if a candidate fails to produce the 'Income & Asset Certificate' at the time of joining, his/ her candidature will not be considered for engagement as an apprentice in the Bank.

Disclaimer: "EWS vacancies are tentative and subject to further directives of Government of India and outcome of any litigation. The engagement is provisional and is subject to the Income & Asset certificate being verified through the proper channels."

The EWS candidates should note that in case they are not in possession of "Income & Assets Certificate" for the **relevant financial year** as per the extant DoPT guidelines on or before the closure of online application date, such candidates should apply under "General (GEN) category only.

Training seats reserved for OBC category are available to OBC candidates belonging to "non-creamy layer". Candidates belonging to OBC category but coming in "CREAMY LAYER", are not entitled for any relaxation/ reservation available to OBC category. They should indicate their category as General OR General (LD/ VI/ HI/ d&e) as applicable.

OBC category candidate should submit the OBC (Non-Creamy layer) certificate on format prescribed by Govt. of India, having "Non-Creamy Layer" clause issued during period 01.04.2026 to the date of taking up engagement, if selected.

B. AGE (as on 01.04.2026):

Minimum 20 years and maximum 28 years as on 01.04.2026 i.e. candidates must have been born not later than 01.04.2006 and not earlier than 02.04.1998 (both days inclusive). Maximum age indicated is for unreserved and EWS candidates. Relaxation in upper age limit is applicable as per Government of India guidelines for SC/ST/OBC/PwBD candidates .

C. RESERVATION FOR PERSONS WITH BENCHMARK DISABILITY (PwBD):

Reservation for Persons with Disability is horizontal within the overall vacancies. Reservation has been provided to Persons with Benchmark Disabilities as per section 34 of "The Rights of Persons with Disabilities Act, 2016". The post is identified suitable for the Persons with undernoted categories of benchmark disabilities as defined in the Schedule of RPWD Act 2016:

Locomotor Disabilities (LD), Visual Impairment (VI), Hearing Impaired (HI) and Other PwBDs 'd' & 'e' categories: "Specific Learning Disability" (SLD), "Mental Illness" (MI), "autism spectrum disorder" (ASD) and "Multiple Disabilities" means multiple disabilities amongst LD, VI, HI, SLD, MI & ASD.

1. **RESERVATION FOR PERSONS WITH BENCHMARK DISABILITY (PwBD):** Horizontal reservation has been provided to Persons with Benchmark Disabilities as per section 34 of "The Rights of Persons with Disabilities Act, 2016". The post is identified suitable for the Persons with undernoted categories of disabilities as defined in the Schedule of RPwD Act 2016:

- I. **Visual Impairment (VI):** Only those Visually Impaired (VI) persons who suffer from any one of the following conditions, after best correction, are eligible to apply.

a. Blindness:

- Total absence of sight; OR
- Visual acuity less than 3/60 or less than 10/200 (Snellen) in the better eye with best possible correction; OR
- Limitation of the field of vision subtending an angle of less than 10 degree. OR

b. Low Vision:

- Visual acuity not exceeding 6/18 or less than 20/60 upto 3/60 or upto 10/200 (Snellen) in the better eye with best possible corrections; OR
- Limitation of the field of vision subtending an angle of less than 40 degree up to 10 degree.

II. **Hearing Impaired (HI):**

- a. **Hard of Hearing:** means person having 60 DB to 70 DB hearing loss in speech frequencies in both ears.

III. **Locomotor Disabilities (LD):**

Only those persons are eligible to apply under Locomotor Disability (LD) category who have inability to execute distinctive activities associated with movement of self and objects resulting from affliction of musculoskeletal or nervous system or both, including Cerebral Palsy, Leprosy Cured, Dwarfism, Muscular Dystrophy and Acid Attack Victims, Spinal Deformity (SD) and Spinal Injury (SI) without any associated neurological / limb dysfunction. Orthopedically challenged persons with following benchmark are covered under Locomotor Disability:

Persons with OA, BA and OAL category should have normal bilateral hand functions.

- a. **"Cerebral palsy"** means a Group of non-progressive neurological conditions affecting body movements and muscle coordination, caused by damage to one or more specific areas of the brain, usually occurring before, during or shortly after birth;
- b. **"Leprosy cured person"** means a person who has been cured of leprosy but is suffering from:
 - i. Loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eye-lid but with no manifest deformity;
 - ii. Manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normal economic activity;
 - iii. extreme physical deformity as well as advanced age which prevents him/ her from undertaking any gainful occupation, and the expression "leprosy cured" shall be construed accordingly;
- c. **"Dwarfism"** means a medical or genetic condition resulting in an adult height of 4 feet 10 inches (147 centimetres) or less;
- d. **"Acid attack victims"** means a person disfigured due to violent assaults by throwing of acid or similar corrosive substance.
- e. **Spinal Deformity (SD) and Spinal Injury (SI)** without any associated neurological / limb dysfunction.

IV. **'d' & 'e':** Only those persons, who suffer from any one of the following types of disabilities, are eligible to apply under this category:

- a. **Autism Spectrum Disorder (Mild)- ASD (M):** Autism Spectrum Disorder means a neuro-developmental condition typically appearing in the first three years of life that significantly affects a person's ability to communicate, understand relationships and relate to others, and is frequently associated with unusual or stereotypical rituals or behaviours.

V. **Multiple Disabilities** means multiple disabilities amongst (A) to (D) above.

Note: Only those persons with benchmark disabilities would be eligible for reservation. "Benchmark disability" means a person with not less than 40% of a specified disability where specified disability has not been defined in measurable terms and includes the persons with disability, where disability has been defined in a measurable term, as certified by the certifying authority.

Guidelines in respect of PwBD Candidates with Temporary Disability: In terms of Office Memorandum No. 18-25/2024-Policy dated 17.12.2025 issued by Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice and Empowerment, Govt of India,

- i. PwBD candidates with disability conditions falling under the category "likely to improve" under temporary disability category, are not eligible for reservation.
- ii. The Conditions i.e. "Progressive, non-progressive or not likely to improve" are treated eligible for reservation.

A person who wants to avail benefit of reservation will have to submit a disability certificate issued by a Competent Authority **as per Government of India guidelines**. Such certificate will be subject to verification/ re-verification as may be decided by the competent authority. The certificate should be **dated on or before last date of registration of application**.

Guidelines for use of scribe & compensatory time:

a). The facility of scribe would be allowed to a person who has **disability of 40% or more** if so desired by the person and is meant for only those persons with disability who have physical limitation to write including that of speed. In all such cases where a scribe is used, the following rules will apply:

- Candidates eligible for and who wish to use the services of scribe in the examination should carefully indicate the same in the online application form. Any subsequent request may not be favorably entertained.
- Both the candidate and the scribe will have to give a suitable undertaking, in the prescribed format with passport size photograph of the scribe at the time of online examination.
- Such candidates who are eligible to use a scribe shall be eligible for compensatory time of 20 minutes for every hour of the examination whether availing the facility of scribe or not.
- Candidate will have to arrange his/ her/ their own scribe at his/ her/ their own cost.
- Any candidate who is not eligible to use scribe as per guidelines, as referred above, uses scribe in the online examination shall be disqualified to participate further in the process of engagement, in addition to any other action that Bank may deem fit against the candidate and the scribe. Any candidate using scribe in violation of the above guidelines can be removed from the service without notice, if already joined the Bank.
- **During the examination, at any stage, if it is found that scribe is independently answering / solving the questions himself, the examination session for such candidate will be terminated, and candidate's candidature will be cancelled. The candidature of such candidates using the services of a scribe will also be cancelled if it is reported after the examination by the test administrator personnel that the scribe independently answered the questions.**
- The scribe arranged by the candidate should not be a candidate for the same online examination. If violation of the above is detected at any stage of process, candidature of both the candidate and the scribe will be cancelled.
- Scribe will be allowed to be used as per the guidelines issued vide Office Memorandum F.No.16-110/2003-DDIII dated February 26, 2013 of Government of India, Ministry of Social Justice & Empowerment, Department of Disability Affairs, New Delhi and clarification issued by Government of India, Ministry of Financial, Deptt. of Financial Services vide letter No. F. No. 3/2/2013-Welfare dated 26.04.2013.

b). Use of Scribe & Compensatory time (persons with specified disabilities covered under the definition of section 2(s) of the RPwD Act 2016 but not covered under the definition of section 2(r) of the said act, i.e persons having less than 40% disability and having difficulty in writing):

In terms of Office Memorandum F. No .29-6/2019-DD-III dated 10/08/2022 of Government of India, Ministry of Social Justice & Empowerment , Department of Empowerment of persons with Disabilities(Divyangjan)) , In addition to the instructions applicable to PwBD candidates (who have disability 40% or more) the facility of scribe and /or compensatory time shall be granted solely to the persons with disabilities covered under section 2(s) of the RPwD Act 2016 but not covered under the definition of section 2(r) of the said act (i.e persons having less than 40% disability and having difficulty in writing), to those having difficulty in writing, subject to **production of a certificate to the effect** that person concerned has limitation to write and that scribe is essential to write examination on his/ her behalf from the competent medical authority of a Government healthcare institution as per prescribed Proforma at Appendix-I of the said O.M. In case the candidate opts to bring his / her own scribe, the qualification of the scribe should be one step below the qualification of the candidate taking the examination. Candidate opting for own scribe should submit details of the own scribe as per Proforma at Appendix-II of the said O.M.

A person who wants to avail benefit of reservation will have to submit a disability certificate issued by a Competent Authority **as per Government of India guidelines**. Such certificate will be subject to verification/ re-verification as may be decided by the competent authority. The certificate should be **dated on or before last date of registration of application**.

D. EDUCATIONAL QUALIFICATION as on 01.04.2026

Graduation from a recognized University/ Institute.

E. DURATION OF TRAINING:

Duration of training is of one year.

F. STIPEND/ BENEFIT:

The apprentices are eligible for stipend of Rs.15000/- per month for the engagement period of one year. **The apprentices are not eligible for any other allowances/ benefits.**

G. WEIGHTAGE/RELAXATION IN RECRUITMENT OF JUNIOR ASSOCIATES:

Weightage / Relaxation to apprentices in recruitment of Junior associates shall be given as per recruitment policy of the bank as amended from time to time. Weightage / Relaxation in recruitment of Junior Associates will be given to the apprentices **who will successfully complete the apprenticeship training in our Bank** and subject to candidate's satisfactory conduct and performance during the entire training period. Successful completion of Apprenticeship training refers to passing of skill evaluation test (Trade test) and Obtention of joint National Apprenticeship Certificate jointly issued by SBI-NSDC / BFSI-SSC.

H. SELECTION PROCESS:

Selection for engagement of apprentices would be based on the basis of **(i) Online written test and (ii) Test of local language.**

i. Online written test:

There will be negative marks for wrong answers in the Objective tests. 1/4th of mark assigned for question will be deducted for each wrong answer.

Candidates are required to score a minimum percentage mark on aggregate (For SC/ST/OBC/PwBD candidates, 5% relaxation available thereon). Minimum qualifying marks on aggregate will be as decided by the Bank. There are no minimum qualifying marks for individual subject. Merit list will be drawn State wise and category wise. Candidates
