State Bank of India invites Online application from Indian citizens for appointment to the following Specialist Cadre Officers on contract basis. Candidates are requested to apply Online through the link given on <https://bank.sbi/careers> or <https://www.sbi.co.in/careers>

1. The process of Registration is complete only when fee is deposited with the Bank through Online mode and successful payment of fee.
2. Before applying, candidates are requested to ensure that they fulfil the eligibility criteria for the post applied for.
3. **Candidates are required to upload all required documents (brief resume, ID proof, age proof, caste certificate, if applicable), educational qualification, experience etc. failing which their application/candidature will not be shortlisted/ interview.**
4. Short listing will be provisional without verification of documents. Candidature will be subject to verification of the original when a candidate reports for interview (if called).
5. In case a candidate is called for interview and is found not satisfying the eligibility criteria (Age, Education, Experience etc.) he/ she will neither be allowed to appear for the interview nor be entitled for reimbursement of any expenses.
6. Candidates are advised to check Bank's website <https://bank.sbi/careers> or <https://www.sbi.co.in> for any updates (including the list of shortlisted/ selected candidates). The Call (letter/ advice), where required, will be sent in hard copy will be sent).

## **IMPORTANT POINTS:**

- i) The number of vacancies including reserved vacancies mentioned above is provisional and requirement of the Bank.
- ii) Candidate must possess the relevant full-time experience as on specified date.
- iii) The relevant experience certificate from employer must contain specifically that the candidate is working in the field as required.
- iv) Candidate belonging to reserved category including Person with Disabilities for whom no reservation is made are free to apply for vacancies announced for General category provided they fulfil all the requirements of the General category.
