Such candidates claiming waiver of examination fee will be required to furnish "Minority Community Declaration" affidavit on non-judicial stamp paper that he/she belongs to any of the above minority communities. **(8) Terms & conditions**

- 8.1 The engagement of Junior Technical Associates on contract basis would be upto 19.11.2023 or till regular selected RRB candidates are available or till the currency of the scheme exists whichever is earlier
- 8.2 The services rendered as Junior Technical Associates on contract basis is a stop-gap arrangement and will not create any prescriptive right for consideration of their period of service in case of regular selection through RRB
- 8.3 The candidates recruited on contract basis will not be entrusted with the duties of quality certification, safety certification, Stores in-charge, certification of measurements in Measurement Book and the like. However, they may assist the regular Railway supervisory in these works and in performance of other day-to-day duties.
- 8.4 The engagement on contract basis will not confer any right to claim for regular absorption/extension in the Railway.
- 8.5 Detailed instructions with regard to duties will be given to the selected candidates along-with the offer of engagement. The selected candidates are required to serve anywhere on South Central Railway on need basis.
- 8.6 The number of vacancies indicated in this notification is provisional and may decrease or even become NIL at a later stage depending upon the actual needs of the Railway administration. The railway administration also reserves the right to cancel the notified vacancies at its discretion and such decision will be final and binding on all. In the event of cancellation of notified vacancies, the processing fee paid by the candidates will not be refunded.
- 8.7 Engagement of Selected candidates is subject to their passing requisite Medical Fitness Test to be conducted by the Railway administration, final verification of educational and community certificate and verification of antecedents/character of the candidates.
- 8.8 Candidate those who are already in service of PSU/Government Organizations and are eligible for the above should produce "No Objection Certificate" for the same from his/her employer.
- 8.9 Candidate's admission for the contractual engagement will be purely Temporary subject to satisfying the prescribed eligibility conditions. Mere issue of Call Letter/e-admit card via Email/whatsapp to the candidates will NOT imply that their candidature has been finally accepted.

- 8.10 Candidates selected against contractual engagement as Jr.TA shall be terminated from service, if the information and documents furnished by him/her for engagement, are found incorrect/fake at any stage.
- 8.11 The decision of selection committee/administration in all matters relating to eligibility, acceptance or rejection of application etc. will be final and binding on the candidates and no inquiry or correspondence will be entertained in this connection.
- 8.12 Candidates who have been debarred for life from any RRB/RRC examinations or candidates who have been debarred for a specific period which is not yet completed need NOT apply in response to this notification. Their candidature will be rejected during any stage of professional ability Test/ Interview as and when detected.
- 8.13 Candidates are required to obtain caste certificates in the proper Proforma from the appropriate authority should be latest but not be more than one year old at the time of document verification, failing which he/she may be disqualified. **12) Medical Examination:**

- (I) Candidates will have to undergo medical examination (as applicable for direct recruitment to the post notified and will be considered for contract engagement only if they are found medically fit in the prescribed category/classification. Medical fitness will be examined by the nominated Railway hospitals.
- (II) The candidates should fulfill the requirements of Medical Standard A-3 as given in Chapter 5 of Indian Railway Medical Manual Volume-1 accessible at [www.indianrailways.gov.in](http://www.indianrailways.gov.in)

**13) Training:**

- i. The candidates engaged on contract basis, will be given training for a prescribed period regarding orientation in rules, regulations and practices related to safety, technical and other areas before they are deputed on work.
- ii. After completion of training/orientation, the suitability/competency of the candidate will be assessed by a Competent Officer, before deputing him/her for field job. If required, the candidates engaged on contract basis, need to undergo for another round of Training/s.

**14) General Guidelines:**

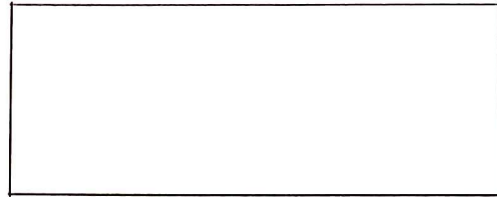
