Subject: Recruitment to the post of Clerk in the Subordinate Courts of
Haryana against Advt. No. 36C/SSSC/HR/2026

Candidates may please refer to Detailed Employment Notice No.: - 36C/SSSC/HR/2026 uploaded on the Website of S.S.S.C on 22.05.2026.

In the light of Instructions issued by Haryana Government bearing Letter No. 01/10/2021-2HR-III dated 25.05.2026 regarding Benefit of reservation to Ex-servicemen and their children, the Competent Authority has decided to amend clause 13 (viii) of the advertisement as under:

- **For:-** Reservation for Ex-servicemen and his family members (son, daughter or spouse) will be governed in accordance with instructions contained in letter Nos.12/15/2019-4GS-II dated 09.03.2022 and 12/15/2019-4GS-II dated 13.04.2022 of Government of Haryana.
- **READ AS:-** Reservation for Ex-servicemen and his family members (son, daughter or spouse) will be governed in accordance with instructions contained in letter No. 01/10/2021-2HR-III dated 25.05.2026 of Government of Haryana.

The concerned candidates shall also be required to upload Certificate/Form of Undertaking in prescribed pro-forma attached as **Annexure-A**, in the online application form.

As the eligibility to apply under Ex-Servicemen of Haryana and family member (Son/Daughter/Spouse) of Ex-Serviceman (ESM) of Haryana categories has gone a change before the last date of the online application form, the same has been made applicable qua the Advertisement dated 22.05.2026 as well.

Hence, it is for the information of the applicants that the candidates who have already successfully applied under Ex-Servicemen of Haryana or family member (Son/Daughter/Spouse) of Ex-Serviceman (ESM) of Haryana categories and are eligible as per the Instructions dated 25.05.2026 referred above need not to apply again. However, they shall be governed by the Instructions dated 25.05.2026 referred above. Further, concerned candidates shall be required to give Form of Undertaking/Certificate in prescribed pro-forma attached as **Annexure-A** as and when so directed.

The candidates who have already successfully applied under the reserved categories of Ex-Servicemen of Haryana or family member (Son/Daughter/Spouse) of Ex-Serviceman (ESM) of Haryana but are not eligible under the Instructions dated 25.05.2026 referred above, if any, their application will be rejected and the fee paid by them will be refunded on furnishing application in said regard containing necessary particulars like details of their application form, bank details etc.

Further, in the interest of candidates, last date for submission of online application for all the applicants is extended till **09.07.2026 04:00 PM**.

All other terms, conditions and details of the advertisement read with corrigendum dated 23.05.2026 shall remain unchanged.
