	(II) Matriculation Plus Course Completed Act Apprenticeship / ITI approved by NCVT/SCVT along with desired sports achievement (Diploma in Engineering is not considered as an alternative higher qualification. Act Apprenticeship/ITI is the only qualification and no other qualification including Diploma in Engineering is accepted as an alternative qualification on the ground of being a higher qualification in the same line of training). The training period for the selected candidates will be as per extant rules. <b>(Authority: Railway Board's letter No. E(NG)II/2018/RR-I/51 Dt. 16.01.2019).</b>
