- **2. Mode of Interview**: Online interview shall be held for shortlisted candidates from India (on WhatsApp or VC App).
- 3. No agents involved: There is no recruitment agent involved in this selection process. Hence, no payment may be made other than the charges mentioned in this Advertisement. TCIL is no way responsible if any such payment is made to anybody.
- **4.** Upon selection of candidates and after completion of all the required visa formalities at KSA and India, the candidates should be ready to travel as per TCIL KSA project requirements at an early date without much delay. In case of any delay shown by candidates more than the prescribed period, it shall be treated as lack of interest and selection can be cancelled.
- **5.** The period of contract is 3 years from the date of joining in TCIL KSA, further extendable on mutually agreed terms.
- **6.** The selected candidate shall be required to execute a bond of INR 3,50,000/- on a Non Judicial Stamp Paper of Rs. 100 at the time of joining. - **3. Provision of air tickets:** Air tickets shall be provided by TCIL KSA to the selected candidates after completion of their visa formalities for their initial travel from India to KSA to join duty. Thereafter, air tickets for vacation travel to India shall be provided at the company's cost only after completion of two years of continuous service. - **6.** After obtaining PCC clearance and GAMCA medical clearance, TCIL KSA shall provide the MOOFA number for obtaining the Medical Certificate from GAMCA. The selected candidates shall provide their passport in coordination with TCIL KSA for VISA Stamping.
- 7. The selected candidate should intimate TCIL KSA as soon as he gets Visa Stamping on their passport so that Air ticket can be arranged by TCIL KSA.
