- Exceptional leadership abilities.
- Strong budgeting, financial forecasting and financial analysis skills required.
- Ability to handle multiple tasks, such as communication and record keeping of multiple projects at a time.
- Strong verbal and written communication skills.
- Analytical thinking to come up with progress plans.
- Ability to collaborate with lead teams.
- Being proactive about Project Leaders requirements.

## Key Responsibilities

- Manage day-to-day accounting operations and ensure that there is a redundant process backup in place for every critical operation.
- Monitoring daily communications and answering any queries.
- Co-ordination between Project accounts staff and TISS accounts section.
- Ensuring payments, amounts and records are correct.
- Raising the bills, invoices and reimbursements for expenditure incurred by different projects.
- Facilitate documentation of utilization of allocated funds.
- Reconciliation of budgeted and actual spends on a fortnightly basis.
- Support Project Leaders in generating Project Budgets, Accounts & Finance related Statements, Documentations, Compliances, Various Reports, Data gathering & analysis.
- Maintain digital and physical financial records.
- Create and update expense reports.
- Any other work assigned by the Project Leader /

Dy. Registrar (F&A) or any other official from time to time.

### Other Conditions.

- (a) The Institute reserves the right to not fill up the vacancy advertised, to invite persons for Personal Interaction (Offline/ Online), who may not have applied for the vacancy as per the procedure.
- (b) Since applications received will be shortlisted, merely possessing the prescribed

minimum qualifications and the requisite experience would not entitle a person to be called for PersonalInteraction (Offline/ Online) in case of high response.

- (c) The position is unreserved, but candidates belonging to reserved category are encouraged to apply.
- (d) No queries or correspondence regarding issue of call letter for selection of candidates for the post will be entertained at any stage and canvassing in any form is strictly prohibited and will lead to the candidate being debarred from consideration for the post.
- (e) It shall be the responsibility of the candidate to assess his/her own eligibility for the post, for which he/she is applying in accordance with the prescribed qualifications, experience etc, and submit his/her application duly filled-in along with the desired information and documents as per the advertisement. Suppression of factual information, supply of fake documents, providing false or misleading information or canvassing in any manner on the part of the candidates shall lead to disqualification. In case it is detected at any point of time in future, even after appointment, that the candidate was not eligible, his/her appointment shall be liable to be terminated forthwith as per this clause.
- (f) In case of any ambiguity in general and eligibility in particular for any post, the decision of the Instituteshall be final.
- (g) No TA/DA is payable for appearing for the Personal Interaction, if it held at the Institute's premises.
- (h) In case of any inadvertent error in the advertisement and in the process of recruitment, which may be detected at any stage, even after issue of appointment order, the Institute reserves the right to modify/ withdraw/ cancel any communication made to the candidate(s).

<u>Application Fee</u>. Application Fee of Rs 500/- to be paid online. Application fee for SC/ST/PWD candidates will be Rs 125/-, if they upload the required Certificate in the Online Application Form. Woman applicants are exempted from the payment of application fee. The application will be valid only on receipt of application fee for those who are required to pay. Fee once paid, shall not be refunded under any circumstances.
