university.

### **Desirable Qualifications:**

- Demonstrates ability in analytics and visualisation, understanding of machine learning, data curation, sustainability reporting framework, and handling micro data.
- Ability to teach across programmes, including postgraduate programs in Analytics and Undergraduate programs in Analytics and Sustainability Studies.
- Demonstrated publication and research output in high-impact journals
- Ability to conceptualise and coordinate fieldwork/internship/exposure visits as part of the course.

### Besides fulfilling the above qualifications, Eligibility (A or B):

**A.** The candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET / SLET / SET for recruitment and appointment of 'Assistant Professor' subject to the or equivalent positions in Universities/Colleges/Institutions fulfilment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) At least two external examiners have evaluated the Ph.D. thesis;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published at least one research paper from his/her Ph.D. work, in a refereed journal. Preferably indexed in scopus

The fulfilment of these conditions is to be certified by the Registrar or the University's Dean (Academic Affairs) concerned.

**Note:** NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

**B.** The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following:

- i. Quacquarelli Symonds(QS)
- ii. the Times Higher Education (THE) or
- iii. the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

# **Application Fee:**

The application fee of Rs. 1000/- be paid online. The application fee for SC/ST/PWD candidates will be Rs. 250/- if they attach the required certificate to the online application form.
